Furnish Labor, Materials and Equipment to Remove and Replace One Air-Cooled Chiller System at the Westbank Regional Library for the Jefferson Parish Library Department

CLARIFICATION:

1. QUESTION: The completion date is 14 days once awarded the job, will this be once the winning bidder receives the equipment that the 14 days will start?

ANSWER: See Section 14.0- Pre-Construction Conference, Notice to Proceed and Invoicing. The fourteen (14) days will start once the Notice to Proceed has been issued.

2. QUESTION: Are we only bidding for a Trane supplied Chiller or like "chiller brands"?

ANSWER: See Section 6.0- Submittals.

3. QUESTION: Are we performing the job to remove and replace the chill water pumps with a new one?

ANSWER: Yes, you will be performing the job but the new pump and circuit setter will be provided by the owner.

4. QUESTION: Will a temp A/C need to be provided while this chiller is being changed out?

ANSWER: No, the projected installation that expects the chiller being operational is one weekend with the library closing one day. All manpower and various trade work must be coordinated to ensure minimal impact of the library. The fourteen (14) day completion time covers testing and coordination with Siemens Building Automated System (BAS), insulating, etc.
