Following are the Vendor's Inquiries received by the deadline date of April 25, 2024 and the State's responses:

**Vendor's Inquiry #1:** What is a sufficient amount of boxes and sharps containers to have on hand for each region?

**State's Response #1:** Approximately 140 boxes (or 20/day) brown card boxes with red biohazard bags are needed weekly for the Medical Needs Shelter(s). Additionally, an in-reserve 140 boxes are needed, in case the waste disposal company is unable to replenish the weekly supply because of weather, supply chain, or other issues.

Vendor's Inquiry #2: Are services only needed during disasters?

State's Response #2: Yes.

**Vendor's Inquiry #3:** Do individual employees need the infectious waste permit or just the vendor?

State's Response #3: Only the vendor will need an infectious waste permit.

Vendor's Inquiry #4: Can gallon sized sharps containers be used at all locations?



**Vendor's Inquiry #5:** Can medical waste that I have retrieved be picked up from my facility in Alexandria by a company that does the disposal?

**State's Response #5:** A vendor may engage subcontractors to dispose of waste that has been retrieved from designated State facilities.

**Vendor's Inquiry #6:** There are sections for autoclave and incineration disposal, is there a preferred method between the two?

State's Response #6: Incineration, as most items used with patients/clients are disposable.

All else remains as on original bid.
