- Approval of Executive Employment Agreement Larry Katz

 Vice Chair Larry Katz stated that the officers met with Jerry Bologna to review and discuss the renewal of Jerry's three-year employment agreement and the officers believe the new employment agreement will bring Jerry more in-line with his peers. The three-year employment agreement was made available for the Board of Commissioners to review. Lloyd Clark motioned, seconded by Gene Sausse to approve the three-year employment agreement. The motion passed unanimously.
- Approval of Nominating Organization(s) to continue serving as a nominating entity for appointments to the JEDCO Board of Commissioners Jerry Bologna
 JEDCO bylaws stat that the Executive Committee shall review the status of each Nominating Organization set forth in the Jefferson Parish Code of Ordinances, Sec. 2-875.9 ("Nominating Organization") upon the completion of each Commissioner's term. If a majority of the Executive Committee determines in its sole discretion that a Nominating Organization has not held a regular business meeting for six (6) consecutive months, or for two (2) consecutive quarters (if meetings are held quarterly), the Nominating Organization shall be considered dormant. If a Nominating Organization is considered dormant, the Executive Committee may recommend to the Parish Council that the Nominating Organization be replaced or be deemed ineligible to continue serving as a Nominating Organization.
