Minutes of the Regular Board Meeting  
Tuesday, January 25, 2022

The SLFPA-W Board of Commissioners met at approximately 4:00 P.M. Tuesday, January 25, 2022 at the SLFPA-W – Office – Board Room, 7001 River Road, Marrero, Louisiana.

Mr. Burke called the public meeting to order and called the roll.
