Regular Meeting Minutes March 7, 2022

Vice President Leward Henry called to order the Board Meeting of the Terrebonne Levee and Conservation District at the Terrebonne Levee & Conservation District Office located at 220A Clendenning Road, Houma, Louisiana, at 6:00 P.M. March 7, 2022.

Angela Hidalgo led the opening prayer and Commissioner Henry led the Pledge of Allegiance to the American Flag.

Upon roll call by Mrs. Hidalgo, Commissioners recorded as present: Cenac, Chauvin, Daisy, Davis, Henry, Moore, and Walker. Commissioners Alford and Williams are recorded as absent.

Under approval of minutes, there was a motion by Commissioner Walker, seconded by Commissioner Chauvin, to approve the meeting minutes dated February 16, 2022. The motion passed without objection.

Under Public, there was no one wishing to address the board.

Under Management's Report, there was nothing to report.

Under Finance Committee Matters, Chairman Moore asked the board to approve HNC Lock Complex Construction Phase 1 (Sealevel) Invoice HNC-P1-003 in the amount of \$994,565.99. Motion: Chauvin, Second: Walker. The motion passed without objection.

Trey Middleton with GIS Engineering provided an update on repairs, insurance estimates, and reimbursements for the floodgates damaged by Hurricane Ida.
