LOUISIANA PHYSICAL THERAPY BOARD

May 19, 2010

Proceedings for the Louisiana Physical Therapy Board, taken in regular session on Wednesday and Thursday, May 19, 2010, at 104 Fairlane Drive, Lafayette, LA 70507. Jerry Jones, Jr., Secretary, Treasurer called the meeting to order on Wednesday, May 19th at 6:30 p.m. A quorum of members was present. Board members present were: Jerry Jones, Jr., Teresa Maize, Donna "Dee" Cochran, Dr Gerald Leglue, and Danny Landry. Cheryl Gaudin, Glenn Ducote, general counsel and George Papale, attorney were present. Advisory Committee Member Tina Gunaldo was present.

ADOPTION OF MINUTES OF PREVIOUS MEETING

Minutes of the April 2010 board meeting and May 5 Special Meeting were accepted as edited.

CHAIRMAN'S REPORT

Jerry Jones welcomed Dr. Gerald Leglue to the board. Dr. Leglue was appointed to the board in April.

TREASURER'S REPORT

Cash on hand for the month of April was \$1,012,256.39. Receipts for April totaled \$11,100.00, and expenses totaled \$24,881.51.

The CD at Union Bank ending with 415 will mature on May 29th. Motion was made by Teresa Maize, seconded by Danny Landry; "To allow Cheryl Gaudin to have signing authority closing CD ending in 415, move \$100,000 of the proceeds into the board's checking account, and to open a new CD with the remaining proceeds at the best interest available." All in favor were Teresa Maize, Danny Landry, Jerry Jones, Dee Cochran, and Dr. Leglue. No one opposed the motion.

EXECUTIVE DIRECTOR REPORT

Cheryl Gaudin received an invitation to participate in the Federation of State Boards of Physical Therapy annual Committee Leadership Meeting held in Alexandria, VA from June 26 – 27th. Participants consist of all committee and task force chairs as well as one other representative from every committee. The purpose of the meeting is to keep member jurisdictions informed about progress toward achieving FSBPT goals and seek views and insights on future and long-term initiatives. The meeting is also an opportunity to hear and discuss different points of view on current regulatory issues. The FSBPT Board of Directors just launched the initial phase of developing a five-year strategic plan of which the Committee Leadership Meeting will provide an opportunity to provide input into the process. The board supported Cheryl Gaudin accepting the invitation to participate.

Can a Podiatrist write P.T. orders for treatment for areas that may not be specifically related to podiatry? For example: The latest script we received from a local Podiatrist had ICD9 codes for

Hammer Toe Deformity and Foot Pain with the specific instructions of: This patient has a history of falling secondary to her CVA. Please provide Physical Therapy for gait training, strengthening, and balance training with the goals of strengthening and limiting her falls.

Rhonda Collins, Administrative Assistant forwarded the CBT Comment Summary Report and Candidate Satisfaction Survey results for January through March 2010 for board review.
