NOPD REPORT:

- **Sgt. Russell gave report. He is trying to implement some changes in the way patrols are conducted. He believes in focusing on visibility and having MCSD patrols more visible. Juveniles are committing burglaries. There is a problem with vagrants who are trespassing. Officer Miguel Aubert is out on medical leave but will be returning. - Al Williams asked for clarification of the AG Opinion.


