

**MINUTES OF THE

The Executive Director reported to the Commission Members Counselor McCranie's legal contract would expire on March 13, 2019. After a brief discussion, Commissioner Krake made a motion to renew Counselor McCranie's contract for one year period, beginning March 14, 2019 and ending on March 13, 2020, for the total of all sums payable under the contract including fees and reimbursement of expenses not exceeding \$50,000.00 on an annual basis. Commissioner Maurice Guidry seconded this motion and it was unanimously approved.

After this time, Chairman Brandt announced a recess of the MVSF's meeting and returned to the LMVC's meeting at 11:00 a.m.

The MVSF's meeting reconvened at 11:20 a.m.

Chairman Brandt called for a reading of the minutes of the October 1, 2018 meeting. Commissioner LeBlanc made a motion to accept the minutes as read. Commissioner Corley seconded this motion and it was unanimously approved.

The Executive Director was directed to include in these minutes the following excerpt from the Louisiana Motor Vehicle Commission meeting immediately preceding this meeting.

The Executive Director reported the applications and supporting documentation were in order for the following initial GAP Administrator applicants.


