CALL TO ORDER

The meeting was called to order by Mr. Bass at 9:24 a.m.

NPDES – Bobby Simoneaux - Mr. Simoneaux reported that the 6th District Court has moved the deadline for full implementation of the permit to October. The LPDES will be shelved for an additional 6 months.

Mr. Bass called for a break at 10:40 am.

Mr. Bass called the meeting back to order at 10:55 am, all commission members were present.

Online Reporting – Tyrone Dudley gave an update on the negotiating of a new contract. There were six companies that applied, and two have withdrawn. There should be a decision in the near future on who will receive this contract.
