**RESTORATION TAX ABATEMENT PROGRAM**

**C & I Board Meeting  
April 26, 2023**

**SPECIAL REQUEST: Ash Brothers, LLC - 20220448-RTA**

On 10/6/2022 Ash Brothers, LLC (“Ash”) filed an advance for a Boat & RV Storage facility project, indicating “major renovation of several buildings”. On 10/31/2022 Ash timely filed one application and corresponding \$500 application fee. However, because the project included multiple structures and program rules require separate applications per structure, LED staff listed the project status as “information required” in Fastlane and advised Ash that additional applications should be filed, detailing investments and renovations per structure. [Likely 4 additional applications, at a minimum additional cost of \$500 per application]. Ash appealed this decision to LED and was denied. Representative Schexnayder, on behalf of Ash, now appeals this matter to BCI.

See attached and below pertinent project documents and authority:

Article VII, Part 2, Section 21 (H) of the Louisiana Constitution provides that:

“...the State Board of Commerce and Industry or its successor, with the approval of the governor and the local governing authority and in accordance with procedures and conditions provided by law, may enter into contracts granting to a property owner, who proposes the expansion, restoration, improvement, or development of an existing structure or structures in a downtown, historic, or economic development district established by a local governing authority or in accordance with law, the right for an initial term of five years after completion of the work to pay ad valorem taxes based upon the assessed valuation of the property for the year prior to the commencement of the expansion, restoration, improvement, or development.”

La. R.S. 4317 provides that:

“The owner of the project granted a limited exemption pursuant to the provisions of this Chapter shall file with the assessor of the parish in which the structure is located any report required by law on forms furnished by the assessor in order that the property granted the limited exemption may be separately listed on the assessment rolls.”

RTA Program rules provides that: “... A separate application must be filed for each structure being restored, renovated, improved or developed. **Exceptions to this Paragraph must be approved in advance by the authorized representative of the board, and approved by the board.**(LAC 13:I.905.C)

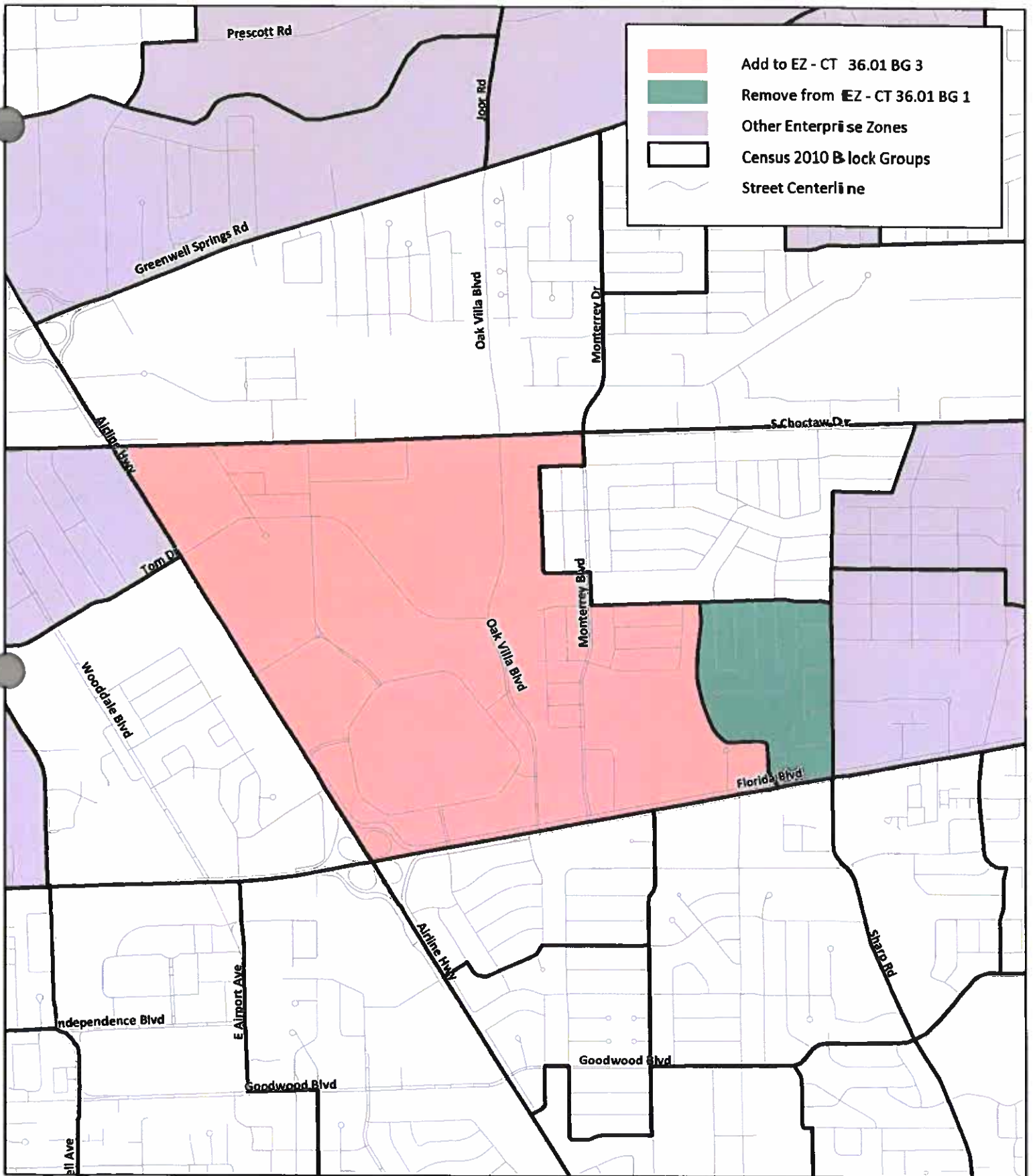

WHEREAS, the City-Parish wishes to designate Census Tract 36.01 Block group 3 in lieu of census tract block group 1 in east Baton Rouge Parish as an enterprise zone;

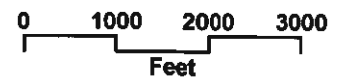
NOW, THEREFORE, BE IT RESOLVED by the Metropolitan Council of the Parish of East Baton Rouge and the City of Baton Rouge that:

Section 2.
