**LOUISIANA MILITARY ADVISORY COUNCIL CERTIFICATION PURSUANT TO LA 42:17.1  
(ACT NO. 302 OF THE 2020 LEGISLATIVE REGULAR SESSION)**

In accordance with LA. R.S. 42:17.1 (ACT NO. 302, 2020 REGULAR LEGISLATIVE SESSION) and there currently being in effect a public health emergency as declared by Governor John Bel Edwards in Executive Proclamation 25 JBE 2020 issued on March 11, 2020 in response to the threat posed by COVID 19, which remains in effect pursuant to Executive Proclamation 145 JBE 2021, issued on August 6, 2021, which declared that a statewide public health emergency continues to exist and which remains in effect from Friday, August 6, 2021 to Wednesday, September 1, 2021, or as extended by any subsequent Proclamation, unless terminated sooner, this notice shall serve as a certification by the presiding officer of the Louisiana Military Advisory Council ("LMAC"), Secretary Don Pierson, that:

- 1) A declared state of public emergency exists through September 1, 2021 in response to the threat posed by COVID-19 as reflected in Executive Proclamation 145 JBE 2021, issued on August 6, 2021;
- 2) An in-person meeting of the LMAC conducted in accordance with otherwise ordinary provisions of the Louisiana Open Meetings Law would be detrimental to the health, safety and welfare of the public;
- 3) The agenda of the meeting to be held on the 24<sup>th</sup> day of August 2021 is limited to matters that are critical to continuation of the business of LMAC and the meeting cannot be postponed or delayed due to a legal requirement or other deadline.

Considering the foregoing and pursuant to LA. R.S. 42:17.1, the Louisiana Military Advisory Council meeting on August 24<sup>th</sup>, 2021 at 10:00 am CDT will be held via video conference and in a manner that allows for observation and input by members of the public as set forth in the notice of such meeting posted herewith.
