 - c. HB 492 - [Act 322](#) eliminates the prescriptive period to commence a civil action against a person convicted of a crime against a child, including human trafficking.
 - d. HB 531 - [Act 324](#) requires the Louisiana Board of Massage Therapy to provide training on human trafficking to its board members, staff, and contract inspectors.
