DPSMV 1777 - Temporary Markers for Auto, Boat and Camper Trailers

SIZE: 12" X 6"

STOCK: 10 pt. white C1S cover: Carolina C1S cover or approved equal. Markers to have 1/2" removable transfer tape across the very top and bottom.

INK:

Black on Face:	Numbering
Black on Back:	All Printing
185 Red on Face:	State Seal (screened to an 8% screen density), outline of Louisiana maps, and 60-day Registration.
287 Blue on Face:	All other lettering and printing not listed above. "Expiration Date" will be reverse printed.

NUMBERING:

Numbers must be 2" tall. Numbering range must be **17300001 - 18300000**. Absolutely no missing numbers are allowed. No overruns or underruns acceptable.

SECURITY FEATURES:

Forms to include a hidden word feature in the expiration area which will show VOID (in the Month, Day and Year blocks), if anyone attempts to photocopy form on a color copier. The line around the expiration date box must be micro printed as ALA Office of Motor Vehicles@ and easily read under magnification.

EXACT REPRINT:

Negatives from previous job can be supplied to the successful vendor.

CONSTRUCTION:

Forms to have 1/2" removable transfer tape across the top and bottom of the forms.

PACKAGING:

Temporary Markers are to be boxed in durable cartons. The inside carton shall be of sufficient depth to be flush with the level of the markers contained therein. Each inside carton, as well as the shipping cartons, must contain a label which shall have the form number of the markers (DPSMV 1777), quantity of the markers contained therein, and the lowest and highest sequential number printed contained therein. All inside boxes and shipping containers are to be sealed with safety tape imprinted with the name of the marker manufacturer. Vendor shall shrink wrap markers 100 per package. Markers must be packaged 1,000 per box, no more, no less. No overruns or underruns are acceptable.

SPECIAL INSTRUCTIONS AND SECURITY MEASURES:

Successful vendor, in accepting this order, shall guarantee that only one copy of each consecutively numbered marker will be produced.

The Department of Public Safety reserves the right to enter the vendor=s premises at any time during the production of the markers to inspect methods of production and to verify full compliance with all provisions and specifications.

Vendor shall establish a thorough system for the immediate disposal of all misprinted or mutilated markers and unuseable board.

Vendor shall indemnify the Office of Motor Vehicles against loss due to the unauthorized use of the marker, unintentional or otherwise, while in the possession of the vendor.

Liquidated damages in the amount of \$10,000 will be imposed on successful vendor for engaging in acts prohibited by the contract.
