HB 971:

House Bill 971, sponsored by Representative Mark Wright, would create the Louisiana Ports and Waterways Investment Commission. This commission would serve as an advocate for all of the state's ports and will be governed by a board of directors mostly appointed by the Governor. HB 971 has passed the House and now moves to the Senate.
