

**MINUTES OF THE GRAND ISLE INDEPENDENT  
LEVEE BOARD OF COMMISSIONERS REGULAR MEETING  
FRIDAY, JUNE 12, 2015  
11:00 A.M.**

The Grand Isle Independent Levee District met on Friday, June 12, 2015, at 11:00 a.m. in a regular meeting at the Grand Isle Multiplex Center with the following commissioners:

Present: 3 Commissioners – David Camardelle, Kelly Besson, Sr. and Arthur Bellanger

Absent: 0

President Camardelle called the meeting to order and then led with the Pledge of Allegiance, followed by a prayer.

A motion was made by Commissioner Besson, seconded by Commissioner Bellanger and unanimously agreed to approve the minutes of the meeting held on May 26, 2015 as read.

President Camardelle stated that Bertucci, the contractor that was awarded the bid for the Fifi Island Restoration Project, will be bringing down equipment today. A meeting will be set up with COE concerning CPA Program to add rocks around Bayou Thunder and discuss dredging of the bar channel and Bayou Rigaud. Mr. Camardelle also stated that the session ended yesterday in Baton Rouge and he was monitoring the bills as the session progressed concerning the coast and levee. He also stated that The Headland Project is currently taking place on Elmer's Island where they are pumping in sand and building up the beach.

President Camardelle thanked the Senator Alario, Representative Gisclair, the Governor's Office, CPRA, and Jefferson Parish officials for helping and supporting the levee board whenever needed. Mr. Camardelle also thanked the Senator Cassidy and Vitter, Representative Scalise and Graves for helping with funding for more rock breakwaters.
