JUDGMENT:

On Monday, September 23, 2024, an open hearing on the merits of this cause was had before the Commissioners of the Louisiana Motor Vehicle Commission (the "Commission") and a determination of the Findings of Fact, Conclusions of Law, and Ruling was made by the Commission.

And after hearing the testimony adduced at trial, the receipt of the documentary evidence admitted into the record, and for reasons orally assigned, the Commission makes the following findings of fact and conclusion of law:

FINDINGS OF FACT:

- 1. Greenger Electric Technology LLC DBA Greenger Powersports, Greenger Motors operated as a recreational products distributor in the state of Louisiana without a license from January 1, 2024, until May 6, 2024.
- 2. Greenger Electric Technology LLC DBA Greenger Powersports, Greenger Motors' actions as recited in paragraph 1, supra, acurred while it was on probation for a 2023 violation of the laws, rules, and regulations administered by the Commission, which probation included a suspension in the payment of \$6,000.00 of an assessed fine should there be no violation of any law, rule, or regulation administered by the Commission.

CONCLUSION OF LAW:

1. Greenger Electric Technology LLC DBA Greenger Powersports, Greenger Motors operated as a recreational product distributor in Louisiana from January 1, 2024, until May 6, 2024, in violation of LA-R.S. 32:1254.A(4).

Considering the forgoing finding of fact and conclusion of law, and pursuant to the authority vested in the Commission as set forth in La.

IT IS ORDERED, ADJUDGED AND DECREED that Greenger Electric Technology LLC DBA Greenger Powersports, Greenger Motors be and is hereby assessed a fine in the amount of TEN THOUSAND FIVE HUNDRED (\$10,500.00) DOLLARS.

IT IS FURTHER ORDERED that SIX THOUSAND (\$6,000) DOLLARS of this fine be suspended conditioned upon Greenger Electric Technology LLC DBA Greenger Powersports, Greenger Motors being placed on ONE (1) YEAR probation beginning the date this judgment is signed and adhering to all Rules and Regulations of this Commission and Louisiana laws applicable to this Commission during the probationary period. In the event of a violation during the probationary period ordered in this matter, the suspended portion of the fine shall become due and payable in full. The type of violation referenced herein does not include any dealer related disputes.

IT IS FURTHER ORDERED that, Greenger Electric Technology LLC DBA Greenger Powersports, Greenger Motors violated 2023 probation and is to pay to the Commission the \$6,000.00 suspended portion of that fine to the Commission.

IT IS FURTHER ORDERED that Greenger Electric Technology LLC DBA Greenger Powersports, Greenger Motors also be and is hereby assessed costs pursuant to La. R.S. 32:1260(C) in the amount of TWO THOUSAND ONE HUNDRED SEVEN DOLLARS AND SIXTY-FIVE CENTS(\$2,107.65), to be paid to the Commission.

FINDINGS OF FACT:

- 1. RJ's Supply Company, L.L.C. DBA Premier Ace Hardware, operated without any license to sell recreational products from July 1st to November 8th, 2023.
- 2. RJ's Supply Company, L.L.C. DBA Premier Ace Hardware offered for sale SIX (6) B-Claw ATV units and it was not licensed by the Commission for this activity.

CONCLUSION OF LAW:

- 1. RJ's Supply Company, L.L.C. DBA Premier Ace Hardware violated Louisiana law by doing business as a recreational product dealer without a license from July 1, 2023 to November 8, 2023.
- 2. RJ's Supply Company, L.L.C. DBA Premier Ace Hardware violated Louisiana law by offering to sell six B-Claw ATV units for which it was neither franchised to sell nor licensed by the Commission to sell.

Considering the forgoing finding of fact and conclusion of law, and pursuant to the authority vested in the Commission as set forth in La. R.S. 32:1251, et seq..

IT IS ORDERED, ADJUDGED AND DECREED that RJ's Supply Company, L.L.C. DBA Premier Ace Hardware be and is hereby assessed a fine in the amount of TEN THOUSAND FIVE HUNDRED (\$10,500.00) DOLLARS.

IT IS FURTHER ORDERED that SIX THOUSAND (\$6,000) DOLLARS of this fine be suspended conditioned upon RJ's Supply Company, L.L.C. DBA Premier Ace Hardware being placed on ONE (1) YEAR probation beginning the date this judgment is signed and adhering to all Rules and Regulations of this Commission and Louisiana laws applicable to this Commission during the probationary period. In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full. The type of violation referenced herein does not include any dealer related disputes.

IT IS FURTHER ORDERED that RJ's Supply Company, L.L.C. DBA Premier Ace Hardware also be and is hereby assessed costs pursuant to La. R.S. 32:1260(C) in the amount of ONE THOUSAND NINE HUNDRED FIFTEEN DOLLARS AND SIXTY-FIVE CENTS (\$1,915.65), to be paid to the Commission.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that SIXTY THOUSAND (\$60,000) DOLLARS of this fine be suspended conditioned upon Maximum Cargo Trailers LLC, within thirty (30) days of the transmission of this judgment, providing proof of insurance covering the period from June 22, 2024 through and including the expiration date of its current license; OR that SIXTY THOUSAND (\$60,000) DOLLARS of this fine be suspended conditioned upon Maximum Cargo Trailers LLC buying the remaining licensable products from Southern Star Equipment Co., 9206-9214 Highway 190 West, Port Allen, LA 70767 within thirty (30) days of the transmission of this judgment to Maximum Cargo Trailers LLC. If no proof is furnished to the commission within said thirty (30) days, the license of Maximum Cargo Trailers LLC shall and will be revoked.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Maximum Cargo Trailers LLC also be and is hereby assessed costs pursuant to La. R.S. 32:1260(C) in the amount of TWO THOUSAND SEVENTY-ONE DOLLARS AND SIXTY-FIVE CENTS(\$2,071.65), to be paid to the Commission.
