**Case No. 17-11-135:** Participant is requesting a full distribution of her account balance of \$8,195 for dental expenses.

The Hardship Committee approved a partial withdrawal in the amount of \$5,071 based on documentation submitted for dental expenses.

**Case No. 17-11-136:** Participant is requesting a partial distribution in the amount of \$4,752.83 of her account balance of \$26,999.69 for vehicle repair.

The Hardship Committee approved a partial withdrawal in the amount of \$4,752.83 based on documentation submitted for vehicle repair.

**Case No. 17-11-137:** Participant is requesting a full withdrawal of his account balance of \$35,808 for loss of wages.

The Hardship Committee approved a partial withdrawal in the amount of \$5,272.26 based on documentation submitted and verified by employer.

**Case No. 17-11-138:** Participant is requesting a full withdrawal of his account balance of \$48,529 for property damage from the August 2016 flood.

The Hardship Committee approved a partial withdrawal in the amount of \$31,273.50 based on documentation submitted for property damage.

**Case No. 17-11-139:** Participant is requesting a partial withdrawal in the amount of \$26,445 of his account balance of \$44,018 for medical expenses.

The Hardship Committee approved a partial withdrawal in the amount of \$26,445 based on documentation submitted for medical expenses.

**Case No. 17-11-40:** Participant is requesting a partial withdrawal in the amount of \$3,000 of her account balance of \$9,771 for medical expenses.

The Hardship Committee approved a partial withdrawal in the amount of \$3,000 based on documentation submitted for medical expenses.

**Case No. 17-11-141:** Participant is requesting a full distribution of her account balance of \$13,657 for mortgage payments that are delinquent.

The Hardship Committee approved a full withdrawal in the amount of \$13,657 based on documentation submitted for mortgage payments.

The Hardship Committee approved a partial distribution in the amount of \$10,000 based on the provisions of the TX-2017-09, Tax Relief for Victims of Hurricane Harvey in Texas, Announcement 2017-11, Relief for Victims of Hurricane Harvey. Participant's daughter met the guidelines of living in an affected county.

**Case No. 17-11-143:** Participant is requesting a partial distribution in the amount of \$16,000 of her account balance of \$55,460 for medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$15,056.28 based on documentation submitted for medical expenses.

**Case No. 17-11-144:** Participant is requesting a partial distribution in the amount of \$20,000 of his account balance of \$65,372 to satisfy a court order stating his mortgage must be paid off on his former community property.

The Hardship Committee did not approve a withdrawal at this time. The committee has requested additional documentation before a decision can be made.
