BUDGET REPORT

Mr. Ty Carlos reported that as of June 30, 2020 the LCDA had earned 76% of the budgeted revenues, while incurring 95% of budgeted expenditures. A motion to accept the May 31, 2020 budget report was made by Mr. David Rabalais, seconded by Mr. Jim Holland and with no opposition the motion carried.

DEVELOPMENT COMMITTEE REPORT

Cowboy Facilities, Inc. - McNeese State University Student Union Project Series 2020 - NTE \$10,000,000

Mr. David Rabalais explained the Development Committee was presented with a Preliminary request regarding the Cowboy Facilities, Inc. -McNeese State University Student Union Project Series 2020. Mr. Rabalais explained the request was relating to the NTE \$10,000,000 million in revenue bonds to construct a new student union on the University campus and repayment would come from an approved fee of students attending the University. A motion for preliminary approval was made by Mr. David Rabalais, seconded by Mr. Jim Holland and without objection the motion carried.

FINAL APPROVAL REQUEST

East Baton Rouge Sewerage Commission Subordinate Lien Revenue Refunding Bonds Series 2020B – NTE \$200,000,000 Mr. Gordon King of Government Consultants as Municipal Advisor presented the final request to the committee on behalf of Mr. Richard Liebowitz and Mr. Tommy Hessburg of Butler Snow Law Firm as Bond Counsel. Mr. King explained the final approval request of NTE \$200,000,000 million in Revenue Refunding Bonds was for the redemption of the Series 2013B Subordinate Lien Bonds. Mr. King explained repayment of the Bonds would come from a dedicated ½ % sales tax for sewerage purposes and revenues of the Commission on a subordinate lien basis. A motion to for final approval was made by Mr. David Rabalais, seconded by Mr. Jim Holland and without objection the motion carried.
