#### 1. CALL TO ORDER

The meeting of the Red River Waterway Commission was called to order by Chair Designee, Troy Roussell, in the Board Room of the Red River Waterway Commission Office located at 5941 Highway 1 By-Pass in Natchitoches, Louisiana.

#### 2. ROLL CALL

Roll was called and a quorum was present. Others in attendance were asked to identify themselves and offer any comments they may have regarding the agenda. However, no comments were offered.

## 4. APPROVAL OF AGENDA

By motion of Commissioner Simpson, seconded by Commissioner Clark, the agenda was unanimously approved. Comments from the public were called for, however, none were offered.

#### 5. APPROVAL OF MINUTES

By motion of Commissioner Fletcher, seconded by Commissioner Crutchfield, the minutes of the November 17, 2021 meeting were unanimously approved.

### 6. TREASURER'S REPORT

By motion of Commissioner Lattier, seconded by Commissioner Clark, the Expenditures, Financial Statements, Investment Reports, & Fund Balance Report for the month of November 2021 were unanimously approved.

#### 7. COMMITTEE REPORTS

#### a) Contracts

Consideration of Authority to Award Design Contract/Poland Floating Dock and Comfort Station/RRWC Project No. 21-11/Contract No. RRW-805: By motion of Commissioner Lattier, seconded by Commissioner Crutchfield, the Commission unanimously approved award of contract for design and administration of the project to Meyer, Meyer, Lacroix and Hixson.

# b) Land Management, Legal Affairs & Affirmative Action

Consideration of Award of Public Bid Land Lease/Pool 4/Tract 2/394 Acres: By motion of Commissioner Lattier, seconded by Commissioner Simpson, the Commission unanimously approved award of land lease to C&J Livestock, LLC, to further be assigned to Charles D. Garrett Cattle Account, LLC, in the amount of \$103,917.50 (\$52.75 per acre) for the 5-year lease term.

<u>Consideration of Award of Public Bid for Sale of Greenhouses:</u> By motion of Commissioner Crutchfield, seconded by Commissioner Lattier, the Commission unanimously approved award of the sale of the three greenhouses to Ed Sylvester Farms, LLC for \$1,806.00.

#### e) Recreation

**Recreation Area Status Report** – Mr. Ryan Ingles highlighted the prepared report provided in the meeting packet, noting that there had been 90,000 visitors to the District recreation areas during the month of November 2021. Updated maintenance items include, but not limited to:

- Annual Turkey Trot run took place at the Stoner Avenue recreation area with approximately 1500 participants
- Fort Buhlow recreation area was the event site for a non-profit group fundraising for special needs children and had approximately 200 in attendance
- Currently painting handrails and re-striping parking lots while weather conditions allow

<u>Marketing Update</u> - A prepared report was provided in the meeting packet. In addition, Marketing Director, Eric Gilmore discussed:

- Attended the Ports Association of Louisiana in December and reported back that there is a lot of movement with the infrastructure bill

- Presenting a listing of 2022 out-of-state travel and conferences at the January 2022 Commission meeting

# g) Revenue, Banking & Budget

<u>Consideration of Approval of 2021 Surplus Equipment List/Authority to Dispose of Items:</u> By motion of Commissioner Crutchfield, seconded by Commissioner Simpson, the Commission unanimously approved the list of items to be surplused and authorized staff to dispose of said items according to State law.

<u>Consideration of Authority to Unreserve-Undesignate Remaining Project Funds:</u> By motion of Commissioner Crutchfield, seconded by Commissioner Maxey, the Commission unanimously approved unreserving-undesignating the remaining project funds of \$213,076.25 still held for the fully completed Coushatta Boat Dock Replacement project.

<u>Consideration of Approval of 2021 Audit and 2021 Statewide Agreed Upon Procedures Audit Engagement Letters:</u> By motion of Commissioner Crutchfield, seconded by Commissioner Clark, the Commission unanimously approved the 2021 Audit engagement letter and 2021 Statewide Agreed Upon Procedures engagement letter with the firm of Payne, Moore & Herrington.

<u>Consideration of Approval of 2022 Budget:</u> By motion of Commissioner Crutchfield, seconded by Commissioner Lattier, the Commission unanimously approved the Red River Waterway Commission 2022 proposed budget and the Resolution for Adoption of the 2022 Budget for the Red River Waterway Commission. Commissioner Crutchfield read the resolution aloud as follows:

WHEREAS, the Red River Waterway Commission has appointed Executive Director, Colin Brown, to prepare and submit a proposed budget to said governing body; and

WHEREAS, Executive Director, Colin Brown, has submitted a proposed budget for Fiscal Year 2022, beginning January 1, 2022 and ending December 31, 2022, to this governing body on December 15, 2021, for its consideration, and;

WHEREAS, upon due and proper notice, published and posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on December 15, 2021, and interested taxpayers were given the opportunity to inspect and comment as to said proposed budget, and;

WHEREAS, the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE Red River Waterway Commission of the State of Louisiana:

Section 1: That the budget as submitted, amended, and summarized by fund, hereby is approved and adopted as the budget of the Red River Waterway Commission for the year stated above.

Section 2: That the budget herby approved and adopted shall be signed by the Secretary/Treasurer and Executive Director.

ADOPTED, this 15th day of December, 2021 after roll call vote of the Red River Waterway Commission.

Additionally, the Commission unanimously approved reserving an additional \$5,000,000.00 for dredging of the Red River.
