Mr. Jeff Roesel, RPC's Executive Director led everyone in the Pledge of Allegiance.

Following the roll call by Mr. Jason Sappington, RPC's Deputy Director, a quorum was established.

1. Consideration: Approval of March 8, 2022 minutes

Mr. Jeff Roesel asked the Board for a motion for the approval of the March 8^{th} minutes. Councilmember T. J. Smith, Jr. made a motion to approve the March 8^{th} minutes, seconded by Mr. Christopher Abadie and approved unanimously by the Transportation Policy members in attendance, as noted by the Chairman.

2. Consideration: Amendment to the New Orleans Transportation Improvement Program, Highway & Transit Elements

Mr. Jeff Roesel referred the members to page 5 of the meeting packet for the amendments to the New Orleans TIP, Highway & Transit Elements, and provided a brief explanation of each item.

There being no questions or objections, the Chairman called for a motion to approve the New Orleans TIP amendments for the Highway & Transit Elements. It was so moved by Mayor LaToya Cantrell and seconded by Mr. Kevin Dolliole and approved unanimously by the Transportation Policy members in attendance, as noted by the Chairman.

3. Consideration: Amendment to the St. Tammany Transportation Improvement Program, Highway & Transit Elements

Mr. Jeff Roesel referred the members to page 6 of the meeting packet for the amendments to the St. Tammany TIP, Highway & Transit Elements, and provided a brief explanation of each item.

There being no questions or objections, the Chairman called for a motion to approve the St. Tammany TIP amendments for the Highway & Transit Elements. It was so moved by Councilmember T. J. Smith, Jr. and seconded by Mayor Clay Madden and approved unanimously by the Transportation Policy members in attendance, as noted by the Chairman.

4. Consideration: Amendment to the Tangipahoa Transportation Improvement Program, Highway & Transit Elements

Mr. Jeff Roesel informed the members there were no amendments to the Tangipahoa TIP, Highway & Transit Elements.

5. Consideration: Unified Planning Work Program for FY-23 Final Document

Mr. Jeff Roesel referred the members to the final document of the Unified Planning Work Program for fiscal year 2023 and stated that this document is inclusive of all four urbanized areas in our region and includes the work tasks and budgets for each task, by urbanized area, four in total. He also mentioned that we submitted a draft of this document in March. Late last week, the FY 22 Transit appropriation was released by FTA, which changed the 5303 planning Transit program in the UPWP as follows:

•Southshore UZA: \$574,439 (federal) (\$143,609 local)
•Slidell UZA: \$51,178 (federal) (\$12,794 local)
•Mandeville/Covington: \$50,416 (federal) (\$12,604 local)
•S. Tangi UZA: \$43,132 (federal) (\$10,783)

Those revisions and the corresponding local match shares are in the revised funding tables for each of the Urbanized areas, and also stated that the changes with FTA Region 6 was advised that the resolutions that were passed last month did not need to be re-accomplished, only the budget tables in the document.

There being no questions or objections, the Chairman called for a motion to approve the Unified Planning Work Program for FY-23. It was so moved by Parish President Kirk Lepine and seconded by Mr. Billy Raymond and approved unanimously by the Transportation Policy members in attendance, as noted by the Chairman.

6. Resolution:

Authorization to Transfer Direct Recipients Status for Federal Transit Administration Section 5307 Urbanized Area Formula Grant Funds from Plaquemines Parish to Plaquemines Port Harbor and Terminal District

Mr. Jeff Roesel referred the members to page 7 of the meeting packet for the Resolution Authorization to Transfer Direct Recipients Status for Federal Transit Administration Section 5307 Urbanized Area Formula Grant funds from Plaquemines Parish to Plaquemines Port Harbor and Terminal District for approval and stated that the Ferry Operation in Plaquemines has recently transferred from the parish to the Port Authority and this would allow the Port of Plaquemines to submit for FTA grants for the ferry operation, specifically section 5307 funding.
