## Louisiana State Board of Examiners of Psychologists BOARD MEETING MINUTES: October 3, 2014

The meeting of the Louisiana State Board of Examiners of Psychologists (Board) was called to order at 8:45 a.m., **Friday, October 3, 2014**, at 8706 Jefferson Highway, Suite B, Baton Rouge, LA 70809. Present were Board Members, Drs. Rita Culross, Marc Zimmermann, Darla Burnett, Phil Griffin, Joseph Comaty; and, Executive Director, Kelly Parker. Dr. Pettigrew, Complaint's Coordinator, was in also in partial attendance for the Complaint Review/Legal Matters discussion.

Dr. Zimmermann. moved to accept the October 3, 2014 agenda. The motion was discussed and passed unanimously. Dr. Burnett moved to approve the September 26, 2014 minutes with minor grammatical corrections. The motion was discussed and passed unanimously.
