#### **MEETING MINUTES**

March 20, 2024

The regular meeting of the Residential Building Contractors Subcommittee was called to order by the Vice Chairman, Curtis Joseph, on Wednesday, March 20, 2024, at 9:35 a.m. at 600 North Street, Baton Rouge, Louisiana.

Mr. Joseph called for any public comments; there was no response.

#### D. COMPLIANCE HEARINGS:
