AMENDMENTS, ADDITIONS, DELETIONS TO THE PROPOSED AGENDA:

Coy Vincent made a motion to accept the Agenda as presented. Evelyn White seconded the motion. All voted and approved.

APPROVAL OF MINUTES:

Meg Lovejoy made a motion to accept the April 2019 regular meeting minutes as presented. Mike O'Quinn seconded the motion. All voted and approved.

APPROVAL OF FINANCIAL REPORT:

Mr. Moreno gave a brief summary of the Financial report for April 2019:

Hotel/Motel Taxes for the 3rd quarter were received in the amount of \$494,975.07. This amount is significantly higher than the same period from the previous year. Mr. Moreno reminded the Board that the 2nd quarter collections were received much earlier than usual, an indication that some of this increase is a possible roll over from that particular quarter. Year to date Hotel/Motel collections are \$1,213,504.00 with the 4th quarter still to be collected. Mr. Moreno reminded the Board that the current cap for Hotel/Motel taxes is \$1.292M.

Mr. Moreno stated that for the month of April, the Income line was \$24,000 over the projected budget. The Arena Concession Income line made up a significant portion of that overage due to the Semien Stables Trail Ride which netted just over \$22,000. Although the event is very taxing it does drives in a substantial amount of revenue for the Authority.

The only line item of note on the Expense side was for Utilities. The Entergy bill for the Events Center was higher than budgeted and Entergy is looking into this to ensure that we are in the best cost-effective program that they have to offer.

The month of April closes out the 10th month of the Fiscal Year and Year-to-Date the total Income is over budget by \$135,000 or 28%, while Expenses are \$50,000 under budget, or roughly 4% below budgeted projections. The cash flow summary has the Authority predicted to finish the fiscal year at just over \$6 million.

Evelyn White made a motion to accept the financial report as presented for April 2019. Meg Lovejoy seconded the motion. All voted and approved.

OLD BUSINESS:

A. Multi-Purpose Arena – Renovations Project Update (Mr. Ellender)

Mr. Ellender presented to the Board the sealed Bids received on April 30, 2019 for the 2019 Improvements to the Arena Complex. Mr. Ellender stated that six sealed bids were received and the lowest bid of \$1,219,929.00 submitted by Scott Taylor Construction is recommended for consideration. Scott Taylor's bid packet was presented to the board for review. The Board reviewed, discussed, and accepted the bid submitted by Scott Taylor Construction for the 2019 Arena Renovations Project.

Meg Lovejoy made a motion to accept the bid submitted by Scott Taylor Construction in the amount of \$1,219,929.00 as presented. Coy Vincent seconded the motion. All voted and approved.
