LOUISIANA BOLL WEEVIL ERADICATION COMMISSION MINUTES

CALL TO ORDER

The meeting was called to order by Mr. Jack Dailey at 10:08 a.m.

ROLL CALL

The roll was called by Tonya Peairs.

Members present: Jack Dailey, Tim White, Dr. Ansel Rankins (representing Commissioner Strain), Ben Guthrie, John Frierson, Kody Beavers, Dr. Michael Salassi (representing LSU AgCenter), and Hank Jones. Alternate members present: Casey Cater, Jason Condrey, and Russ Ratcliff.

A quorum was present.

Others present: Tina Peltier (LDAF), Angela Jackson, Esq. (LDAF Counsel), Tabitha Irvin, Esq. (LDAF Counsel), and Tanika Starks (Hearing Officer).

PUBLIC COMMENT

Ms. Jackson took the time to update the commission on voting procedures.

ELECTION OF OFFICERS

Motion: Mr. Guthrie made a motion to re-elect Jack Dailey as Chairman and Tim White as Vice-Chairman. Mr. Beavers seconded the motion. Motion passed unanimously.

APPROVAL OF MINUTES

Motion: Mr. White made a motion to approve the minutes of the March 23, 2023, meeting. Mr. Frierson seconded the motion. Motion passed unanimously.

ADJUDICATORY HEARING

<u>STIPULATED CASES</u> 23-BWEC-04 – D & V FARMS/DAVID OR VALERIE GILMORE

Mr. Gilmore was not present nor represented by counsel.

The LDAF charged Mr. Gilmore with 23 violations of LAC 7:XV.323 (B) which requires cotton producers to destroy their stalks by December 31 of each crop year.

The LDAF recommended a fine of \$17,250.00 with \$16,750.00 of the fine suspended on the condition that no further violations occur through December 31, 2026. The remaining \$500.00 shall be made, due and payable within 30 days after the Commissioner of Agriculture's final decision in the matter.

Mr. Dailey and Mr. Beavers recused themselves from this matter, citing a relationship with the Respondent as a neighbor and family member respectively.

Motion: Mr. White made a motion to find Mr. Gilmore/D & V Farms LLC in violation of the Boll Weevil Eradication Rules & Regulations, and to accept the stipulation and penalty as written. Dr. Rankins seconded the motion. Motion passed unanimously.

23-BWEC-05 – TYLER GILMORE

Mr. Gilmore was not present nor represented by counsel.

The LDAF charged Mr. Gilmore with 23 violations of LAC 7:XV.323 (B) which requires cotton producers to destroy their stalks by December 31 of each crop year.

The LDAF recommended a fine of \$17,250.00 with \$15,320.00 of the fine suspended on the condition that no further violations occur through December 31, 2026. The remaining \$1,930.00 shall be made due and payable within 30 days after the Commissioner of Agriculture's final decision in the matter.

Mr. Dailey and Mr. Beavers recused themselves from this matter, citing a relationship with the Respondent as a neighbor and family member respectively.

Motion: Mr. White made a motion to find Mr. Gilmore in violation of the Boll Weevil Eradication Rules & Regulations, and to accept the stipulation and penalty as written. Mr. Frierson seconded the motion. Motion passed unanimously.

REQUEST FOR WAIVER OF MAINTENANCE FEES

Mr. Moreau advised the commission that he had spoken with each of the producers that had requested waivers, except for Clint Thomason. All had destroyed their cotton stalks as required by the Boll Weevil Eradication Rules & Regulations. Trent Clark was able to

carry out his crop through to harvest. Mr. Moreau recommended a denial of Mr. Clark's request for a waiver of maintenance fees.

Motion: Mr. White made a motion to approve the requests for waivers of maintenance fees as requested by: Mr. Thomason, HS Planting Co. Inc, Willis Nelson, and Courtney Nelson. Mr. Beavers seconded the motion. Motion passed unanimously.

Motion: Mr. Guthrie made a motion to deny Mr. Clark's request for a waiver of maintenance fees. Mr. Frierson seconded the motion. Motion passed unanimously.

Report from the Commissioner

Dr. Rankins gave an update on employee appointments within the division of Agricultural & Environmental Sciences. He updated the commission members on the Cotton Seed Bug Survey. Dr. Rankins reminded the commission to be mindful of new legislation during the current legislative session that can affect the agriculture industry.
