GMHC Security	Dr. Kasofsky	 The grant also provides funds for client transportation. Bureau of Prisons (BOP) Contracts funded by Federal dollars – Dr. Kasofsky provided background information on this grant. CAHSD had been awarded this contract previously but then was underbid and BOP went with the low bidder. There are three district contracts. There was discussion regarding the difficulty in hiring staff to work these grant programs. One contract is for addiction treatment and two are for MH; EBR Parish Ascension Parish and Livingston Parish. The BOP regions are different from LDH's. CAHSD is subcontracting with the previous provider for a night clinic and an offsite Saturday clinic. TTI Grant-This grant is funded to train mental health practitioners to work more comfortably with people who have a developmental disability. Clinicians at Children's Behavioral Health Services (CBHS) will receive this training. Law enforcement has started providing security at GMHC effective today. The Sheriff's office will begin providing security in the 	
Medication-Assisted Treatment (MAT)	Dr. Kasofsky	 Donaldsonville Clinic on Wednesday. MAT uses Suboxone, Vivitrol, or methadone to help people with an opioid addiction. Vivitrol is currently being offered at CAHSD inpatient and outpatient clinics. Vivitrol is a once a month injection used after a client is detoxed from an opioid. Vivitrol prevents a person from getting a high from opioids and reduces cravings. Behavioral therapy is an important part of this program. CAHSD plans to add Suboxone to outpatient clinics and CARP, and to receive reimbursement. Dr. Kasofsky reported the goal is for Dr. Cataldie to set up his treatment program as a satellite at CAHSD. CAHSD would do the bio-psychosocial.
