VII. NEW BUSINESS - fine matrix

Mr. Steve Sessums explained the new fine matrix, which is based on the penalty accuracy rate and the number of times their stores have been brought before the Commission. Mr. Steve Sessums answered any questions the Commission had in regards to the new fine matrix system.

VIII. OLD BUSINESS

Mr. Benjy Rayburn updated the Commission members on the 2015/2016 Legislative session, which pertained to the budget for the Department. However, our Office of Agro-Consumer Services & Weights and Measures division we are primarily self-funded so our office was not affected by the states General fund cuts.

Mr. Benjy Rayburn discussed some regulations changes we are looking at:

- 1.) Once fuel at a gas station is condemned from sale, to put some restrictions in place and better documentation to track the condemned fuel
- 2.) Definitions to be added for biomass-based diesel, and fuel alternative fuels on the market place

Mr. Benjy Rayburn informed the Commission we did have one piece of Legislative that is waiting on the Governor's signature, which amends the Weights and Measures Law title-3 chapter 30 that says the Commissioner of Agriculture should have the duty and authority to assist the Secretary of the Department of Revenue in collecting taxes and any interest or penalties due This deals with sale of compressed natural gas, which our Department Laws exclude us from regulating.

Mr. Steve Sessums informed the Commission that gas card skimmers and gas pump skimmers are here in our State
