Ms. Lindsey Hunter requested the LDAF price verification inspection reports be submitted into evidence as LDAF exhibits 2, 3, 4, and 5

Mr. Michael Vallan asked the Commission members if they had any questionsnone

Ms. Lindsey Hunter requested the Respondent letter be submitted into evidence and labeled LDAF exhibit R-1

The Department recommended a fine of \$700.00 be imposed on the condition that the respondent pays the penalty by certified funds within 30 days after receipt or notice of the Commissioner's final determination

Then Ms. Lindsey Hunter presented the price verification inspection report's dated 02/07/13, 04/18/13, 10/31/13 and 09/30/14 and requested Ms. Teri Berken to explain each inspection report

Ms. Lindsey Hunter requested the LDAF price verification inspections reports be submitted into evidence as LDAF exhibits 2, 3, 4, and 5

Mr. Michael Vallan asked if the Commission members had any questions- none

Ms. Lindsey Hunter requested the Respondent letter be submitted into evidence as LDAF exhibit R-1

Mr. Michael Vallan stated let the record reflect LDAF exhibits 1 through 5 have been accepted into evidence

Mr. Michael Vallan asked the Commission members if there was a motion to find In and Out Mini Mart # 8 in violation of the Weights & Measures Laws for 9 violations as outlined in the charge letter.

Mr. Steve Sessums asked the Commission members for recommendations as to the constant problems with the Dollar General stores.

Mr. Brad Terral had two recommendations first one if the stores are not making any effort to make changes then charge them the max-stipulated fine and the second recommendation would be to have the inspectors visit the stores more often.

Mr. Steve Sessums said part of the problem is also the prices change so drastically the Manager's just do not have time to make the price changes in a timely manner.

Mr. Mike Miller said the problem is also they change Managers so often

Mr. Steve Sessums is also taking an extra step that when he issues a warning letter to the store he also sends one to the legal counsel at corporate headquarters. In addition, when Corporate gets the warning letter they will in turn contact the District Manager of the store to make sure they have received the letter.

Mr. Marcy LeBlanc made a suggestion that there needs to be some kind of guideline for setting the stipulated fines.

Mr. Frank LoPinto wanted to know if the Commission members recommend the maximum fine what can the defendant do if they do not accept the fine.

Ms. Lindsey Hunter addressed this question.

Mr. Brad Terral asked Mr. Benjy Rayburn why the Commission does not see much scale or fuel quality violations. Mr. Benjy Rayburn explained if we find a problem with a scale or fuel dispenser, The Department can red tag the scale until it is fixed and tie down the fuel dispenser until the repairs are made without shutting the entire store down.

Mr. Marcy LeBlanc wanted to know why the Department could not red tag the cash register that is ringing up the wrong prices the same way we handle the scales and fuel dispensers that are not working properly. Mr. Steve Sessums explained because the cash registers are part of the same pricing system and you would have to shut down every register, and the store would have to close and that is against the law.
