F. REPORTS

1. Chair of the Board Report

Chair Hardy provided the following report:

- ❖ Congratulated the colleges who recently held ribbon cutting events for new spaces on the campuses. The events were well attended and continue to show the need for growth within the LCTCS System.
 - Baton Rouge Community College's McKay Automotive Training Center on March 15th
 - River Parishes Community College's Technical Training Center on March 29th
 - South Central Louisiana Technical College held two ribbon cutting ceremonies on March 31st – the Marine Operations Center at the Young Memorial Campus and the Process Technology and CATE Building at the Reserve Campus
 - Louisiana Delta Community College's Winnsboro Campus on April 7th
- ❖ The Annual Skills USA Louisiana Competition will be held April 27-28, 2017, in Shreveport at the Northwest Louisiana Technical College Campus.
- ❖ Noted that commencement season is approaching. Stated that a schedule of LCTCS commencements has been provided to Board members and sent to each by email. He urged Board members to attend at least one commencement this spring and asked that they let Sara Kleinpeter know their plans on attending.
- ❖ As is protocol for open meetings, there is an opportunity for public comment at the end of the meeting. If you wish to make comments to the Board, please fill out a comment card and turn it into Sara Kleinpeter, Board Coordinator.

2. President's Report

Dr. Sullivan provided the following report:

- ❖ Provided the following campus updates:
 - Bossier Parish Community College's Open Campus™ program was selected to receive the University Professional and Continuing Education Association (UPCEA) Strategic Innovation in Online Education Award. This national award recognizes that BPCC has, at an institutional level, set and met innovative goals focused on online education and has been strategic in the planning, development, implementation and sustainability in line with the institutional mission. The BPCC Open Campus is a world renowned online education tool.
 - BPCC received an endowment match from the Board of Regents in the amount of \$300,000
 - South Louisiana Community College received a number of matches for the campuses:
 - o \$30,000 endowment match from The Lemoine Company
 - o \$25,000 donation from Capitol One for summer camps
 - o \$210,000 in donations and matches from various donors
 - o \$15,000 donation from Oceans Behavioral for the new medical facility

- ❖ Many college foundations conduct internal giving campaigns at their respective colleges. Recently, Northshore Technical Community College conducted an internal giving campaign and received a 100% participation from staff and faculty. Dr. Sullivan congratulated Chancellor Wainwright and his staff for such a successful campaign.
- ❖ Provided the Board with a budget update:
 - Subcommittee on post-secondary education will hear budget testimony from higher education leaders and other entities, including the executive budget.
 - The current fiscal year ends June 30, 2017. LCTCS Colleges are working to “close the books” in a way that meets the mark and within budget.
 - Fiscal Year 2018 presents a current shortfall that is large and contains a loss of sales tax. There are a number of proposals in the coming months that will present a unified message to influence long term, stable funding to the budget challenge.
 - We are not a cause to the state budget problem, we are a solution to the revenue problem in Louisiana. LCTCS Colleges produce people that are working, taking care of families, and paying taxes in Louisiana.

G. GENERAL ACTION ITEMS**

Supervisor Ogé presented the Academic & Student Affairs Actions agenda items for consideration by the Board.

Academic and Student Affairs Actions

1. Establishment of a Center of Workforce Excellence in Cyber Technology at Bossier Parish Community College

BPCC Chancellor Rick Bateman, along with Sandra Partain, Dean of the Technology, Engineering, and Math department and Dr. Paul Spivey, Project Director of the CSRA Program with LED addressed the Board. BPCC is excited about the work that is going on in the area of cyber technology. It is a shining example of how colleges can work with industry to provide improved employment opportunities to the local workforce that benefits the needs of industry. Dr. Spivey shared a video with the Board that provided support for the approval of the BPCC Center of Workforce Excellence in Cyber Technology. Chancellor Bateman thanked Supervisor Spohn for their successful collaboration with the Cyber Innovation Center in Bossier City. Supervisor Spohn stated his support for this Center of Workforce Excellence designation for BPCC.

Dr. Sullivan thanked Chancellor Bateman and the BPCC team for a job well done for their presentation to the Board, and for their dedication to industry alliance in Bossier Parish and the surrounding community.

On motion by Supervisor Strong, seconded by Supervisor Spohn, the Board voted to approve the establishment of a Center of Workforce Excellence in Cyber Technology at Bossier Parish Community College. The motion carried.

2. Student Referendum for Nunez Community College

Nunez Community College Chancellor, Tommy Warner, Jacob Bianchini, Nunez SGA President, and Becky Maillet, Dean of Student Services at Nunez, addressed the Board. The SGA is requesting approval for a referendum to be brought forward to the Nunez students for a vote to assess a student activity fee in future semesters. Mr. Bianchini noted that a fee, if approved, would help to improve the student life experience at Nunez and in turn help with retention and enrollment rates.

On motion by Supervisor Potts, seconded by Supervisor Burgess, the Board voted to authorize the Student Government Association of Nunez Community College to conduct a referendum to assess a \$3 per credit hour student activity fee on all students each semester, capped at 12 credit hours per semester, effective for the 2017 summer term. The motion carried.

Upon the suggestion by Supervisor Burgess, Dr. Sullivan will discuss with the Leadership Team a plan to work with their respective SGA offices to see that all SGAs have some sort of student activity fee tied to credit hours.

Dr. Sullivan acknowledged Dr. Paul Carlsen for the work he's done for the colleges and board office for LCTCS. Dr. Carlsen is leaving in June 2017 to take a position as President of Lakeshore Technical College in Wisconsin. Dr. Sullivan congratulated Dr. Carlsen and wished him the best success in his new endeavor.

Supervisor Carter presented the Facilities Actions agenda items for consideration by the Board.

3. Naming of the Louisiana Delta Community College Winnsboro Campus Library

On motion by Supervisor Mount, seconded by Supervisor Toups, the Board voted to authorize Louisiana Delta Community College to name the new Learning Resource Center at the Winnsboro campus in honor of the late Luella V. Snyder. The motion carried.

4. Naming Opportunities at South Louisiana Community College Health & Sciences Building and Evangeline Campus in St. Martinville

On motion by Supervisor Grissette, seconded by Supervisor Toups, the Board voted to authorize South Louisiana Community College naming opportunities at South Louisiana Community College:

This naming right is made possible by a \$25,000 investment from Elder Outreach

Brett J. Mellington Student Commons

This naming right is made possible from the Lafayette Economic Development Authority, as part of its \$210,000 commitment to the Act 360 Match. This area honors former LCTCS Board of Supervisor and current SLCC Foundation Vice President, Mr. Brett Mellington.
