POST MEETING MINUTES

September 26, 2024

A regular meeting of the Louisiana POST Council was held Thursday, September 26, 2024, at the West Baton Rouge Convention Center in Port Allen, LA. Sheriff Ard called the meeting to order.

POST In-Service Training – 2023 POST In-Service Training Waiver Requests - Medical

POST Revocation Appeal Hearing - Preston Bennett (Level 1)

Ms. Taylor Hill asked if Mr. Bennett, or a representative, was present and no answer was heard. Sheriff Breaux made a motion to defer the revocation appeal hearing to allow Mr. Bennett to attend the next POST Council meeting. After some discussion, Chief Conley seconded the motion and the motion passed.

POST Revocation Appeal Hearing – Jason Paul Ledet (Level 1)

Ms. Taylor Hill presented the revocation appeal request from Mr. Ledet and Chief Marcus Crochet (Welsh Police Dept.), and the POST staff recommendation for approval of the appeal request. Sheriff Breaux made a motion to approve the revocation appeal request and reinstate Mr. Ledet's POST certification. After some discussion, Chief Conley seconded the motion and the motion passed.

Chief Layrisson requested that Noah Johnson be eligible for the out-of-state transfer course without meeting the out-of-state transfer minimum required hours. Sheriff Ard made a motion to table the request for further review. After some discussion, Mr. Terrell seconded the motion and the motion failed (2 yes, 4 no). Sheriff Breaux made a motion to deny the request. After some discussion, Col. Hodges seconded the motion and the motion passed (4 yes, 2 no).

Ms. Taylor Hill presented an Officer Involved Shooting Investigator Certification request, recommended for approval by the OIS Investigator Training Committee, for David Sibley (Lafayette Police Dept.). Chief Conley made a motion to approve the certification request, as recommended. After some discussion, Constable Thomas seconded the motion and the motion passed.

Sheriff Ard made a call for other business, and none was heard.

Mr. Pitre made a motion to adjourn the meeting. Mr. Terrell seconded the motion and the motion passed.
