#### **POST MEETING MINUTES**

September 28, 2023

A regular meeting of the Louisiana POST Council was held Thursday, September 28, 2023, at the West Baton Rouge Convention Center in Port Allen, LA. Sheriff Ard called the meeting to order.

# POST Certification Revocation Hearing – Tyron Andrepont (Level 1)

Ms. Taylor Hill informed the Council members of Mr. Andrepont's felony conviction. Ms. Taylor Hill asked if Mr. Andrepont, or a representative, was present and no answer was heard. Chief Layrisson made a motion to revoke Mr. Andrepont's POST Basic Peace Officer certification. After some discussion, Sheriff Stassi seconded the motion and the motion passed.

# POST Certification Revocation Hearing – Van Clayton Ballard (Level 1 & Level 3)

Sheriff Stassi made a motion to accept the voluntary surrender of Ms. Rios' POST Basic Correctional Peace Officer certification. After some discussion, Mr. Dwight seconded the motion and the motion passed.

POST In-Service Training - 2022 POST In-Service Training Waiver Requests (Medical)

Ms. Taylor Hill presented the recommendation of the POST In-Service Training Committee to approve all medical waiver requests. Chief Layrisson made a motion to approve all medical waiver requests. After some discussion, Mr. Dwight seconded the motion and the motion passed.

Officer Involved Shooting (OIS) Investigator Certification - OIS Investigator Training Waiver Requests - Approvals

Ms. Taylor Hill presented the list of waiver requests recommended for approval by the OIS Investigator Training Committee. Sgt. Davis made a motion to approve the waiver requests as recommended. After some discussion, Chief Layrisson seconded the motion and the motion passed.

Officer Involved Shooting (OIS) Investigator Certification - OIS Investigator Training Waiver Requests – Approvals Pending

Ms. Taylor Hill presented the list of waiver requests recommended for "approval pending" by the OIS Investigator Training Committee. Sheriff Stassi made a motion for the POST Staff to approve these waiver requests when the required training is completed and submitted to POST. After some discussion, Mr. Dwight seconded the motion and the motion passed.

Officer Involved Shooting (OIS) Investigator Certification - OIS Investigator Training Waiver Requests - Denials

Ms. Taylor Hill then presented the list of waiver requests recommended for denial by the OIS Investigator Training Committee. Sgt. Davis made a motion to deny the waiver requests as recommended. After some discussion, Sheriff Stassi seconded the motion and the motion passed.

Officer Involved Shooting (OIS) Investigator Training Course Approval Request

Ms. Taylor Hill presented the OIS Investigator Training Course recommended for approval by the OIS Investigator Training Committee. Chief Layrisson made a motion to approve the training course. After some discussion, Mr. Dwight seconded the motion and the motion passed.

Ms. Taylor Hill thanks all the hosting agency heads for the upcoming 2023 POST Firearms Instructor Retrainers and invited all Council members to attend any/all of the training sessions.
