#### **OLD BUSINESS**

## POST Revocation Appeal Hearing - Preston Bennett - Level 1

Sheriff Breaux made a motion to table the request, per Sheriff Ard's recommendation. After some discussion, Chief Conley seconded the motion and the motion passed.

## POST School Resource Officer (SRO) Training – Basic and Advanced SRO Policy Updates

Ms. Taylor Hill presented the updated POST Basic and Advanced SRO Policies. Sheriff Breaux made a motion to approve the updated policies. After some discussion, Mr. Freiman seconded the motion and the motion passed.
