The commission was informed that a stipulation agreement had been reached between LDAF and the respondents whereby the respondents neither agree nor deny the violations but accept the penalty as presented. Case evidence, Exhibit 1 - Charge Letters sent via Certified Mail with signed receipts and Exhibit 2 – Signed, witnessed and notarized Stipulation letters were presented to the commission by LDAF legal counsel, Christopher Mora and Seed Programs Assistant Director Lester Cannon. Lindsey Hunter accepted the evidence presented.

The stipulation agreement required that each respondent be charged a penalty of Five Hundred Dollars (\$500.00), whereby the Department agreed to waive half of the fine for a first-time offense for a total payable penalty of Two Hundred, Fifty Dollars (\$250.00), per respondent. The suspended amount is for a probationary period of one year barring that there are no further violations by that company during that time.

**Motion** to accept the stipulation letters as the findings of facts and conclusions of law and to accept the recommended penalty of Two Hundred, Fifty Dollars (\$250.00) per violation, per respondent was made by Mr. Michael Hensgens and seconded by Mr. James Monroe. Motion passed unanimously.
