CALL TO ORDER

The meeting was called to order at 9:05 a.m. by Mr. Fred Bass, Confidential Assistant to Commissioner Mike Strain.

ROLL CALL

The roll was called by Mrs. Tina Ficklin.

The following commission members or their Designees were present: Mr. Fred Bass, Designee for Commissioner Mike Strain; Dr. Philip Elzer, Louisiana Agricultural Experiment Station; Dr. Steve Linscombe, Louisiana Cooperative Extension Service; Mr. Michael Hensgens, Seed Industry. A quorum was declared.

PUBLIC COMMENT

No public comment.

APPROVAL OF THE MINUTES

Motion: Dr. Philip Elzer made a motion to approve the proceedings as written from the October 23, 2014 Louisiana Agricultural Chemistry and Seed Commission meeting. Dr. Steve Linscombe seconded the motion. Motion approved unanimously.

SET NEXT HEARING DATE

A date for the next hearing was not established. Lester Cannon recommended a Spring 2016 meeting and will notify the commission and involved parties once the date is confirmed. All parties were in agreement.

OLD BUSINESS

Lester Cannon gave an update on the red rice/weedy rice plant discussion. Mr. Cannon reported that no unidentified plants of this nature were found during the 2015 field inspections. Mr. Cannon surveyed other states and found that Louisiana's seed certification standards were adequate or surpassed other states' isolation and land requirements. It was also found that Louisiana's standards met or surpassed the recommendations of a study performed by AOSCA, entitled International Study On Pollen Flow In Rice Fields. Upon discussion with LSU Ag professionals and individuals from the rice industry, it was determined that Louisiana would continue to be proactive in addressing potential problems by monitoring the issue and maintaining open communication with involved parties. It was further determined that no changes to Louisiana Seed Certification Standards were required at this time.

NEW BUSINESS

Agricultural Chemistry Programs Division: Update on the Food Safety Modernization Act Dr. Mark LeBlanc gave an update on the Agricultural Chemistry Programs and on the status of the FSMA.

LDAF Seed Programs Division: Update on the Seed Programs activities Kevin Wofford gave an update on Seed Programs.

Legislative changes

Recent legislative changes to the Seed Law were enacted to 1) require seed labelers, of seed being sold or offered for sale in Louisiana, to register as a Seed Dealer, and 2) increase the statutory limit for a Seed Dealer license to \$200.00, and the Quarterly Seed Inspection fee to \$0.30 per hundred pounds of seed; thereby allowing LACSC to increase fees to allow the Seed Programs Division to become more self-sufficient if necessary.

Operational changes

Seed Programs Division implemented a new seed database program administered by USAPlants on July 1, 2015. The new program allows seed dealers and consumers online access to pay fees, file reports, print licenses and view analysis reports.

LDAF hired additional field inspectors across the state.

Request for recertification of Mermentau variety rice

Lester Cannon presented a request from Crowley Grain Driers, Inc. to re-certify the Mermentau rice variety. Due to a grain contamination issue found in the registered class of Mermentau rice there is suspected to be a shortage of registered seed for the 2016 planting season. After

consulting with other states' availability of registered Merementau, Mr. Cannon reported that there is a seed shortage and is requesting a motion to accept the recertification of certified Mermentau rice for a period of one year.

Motion to accept the recertification of certified Mermentau for the 2016 planting season was made by Michael Hensgens, seconded by Dr. Steve Linscombe. Motion passed unanimously.

Proposed Amendments

Proposed change to \$121.A Seed Dealers License - to increase the fee from \$100 to \$150 annually to help defray the cost of administering and regulating the seed industry. The last increase in the license fee was in July 2010.

Proposed change to \$123.A Seed Regulatory Fee – to increase the fee from \$0.20 to \$0.25 per hundred pounds of agricultural or vegetable seed at the first point of sale in Louisiana. Last increase was in 2003.

Proposed to change §123.C and D - replace the word "inspection" with the word "regulatory" to be consistent with the language in the Seed Law.

Proposed change to \$763.A.3 Sugarcane Tissue Culture Certification Standards - to allow the source of registered stock from the second ratoon of plantlets produced through tissue culture of foundation material. The source is currently limited to the first ratoon of foundation plantlets. This will give certified producers the ability to more easily recognize the threat of plant off-types before the material is increased throughout the industry.

Proposed change to §763.E Field Standards - to include Eastern Black Nightshade into the noxious weed list; strike Browntop panicum from the Other Weeds section, as it no longer poses a threat to the industry; strike the word "virus" from Sugarcane Mosaic as it has been determined there are other causal agents that are not viruses; strike Mexican Rice Borer and replace it with all Sugarcane Stem Borers for a broader scope of potential threat.

Proposed change to the §749.B Seed Rice Certification Standards Field Standards - to increase land requirements for hybrid rice varieties to five years.

Proposed change to §519.2.b Processing of Certified Seed - to strike the language as it applies to the registered seal requirement on registered seed packaged in super bags. Packaging in super bags is now common throughout the industry and super bags contain a registered seed tag. Therefore, it is no longer necessary to attach a registered seal to the container.

Motion to accept proposed amendments made by Dr. Steve Linscombe, seconded by Michael Hensgens. Motion passed unanimously.

Motion to accept a Resolution for Adoption of Regulation made by Michael Hensgens. Seconded by Dr. Steve Linscombe. Motion passed unanimously.

Motion to accept the recommended penalty of four hundred dollars (\$400.00) per violation for a total fine of sixteen hundred dollars (\$1600.00) was made by Dr. Philip Elzer and seconded by Mr. Michael Hensgens. Motion passed unanimously.
