# **NEW BUSINESS**

# **Director's Report:**

Dr. Rankins introduced new inspectors from the Opelousas district: Ryan Hackett, Breana Porche, David Hinton and Travis Huval; Jason Anderson from our Baton Rouge district; our manager in the New Orleans office, Milton Schleisman, as well as Rose Broggi.

Dr. Rankins also introduced Kristen Hoffman who joined our Horticulture team August 26, 2019. Kristen replaced Andrea Marchand (Andie) in our licensing section and Andrea has replaced Christie Lane as Administrative Assistant IV to Ms. Peltier. We will miss Christie and we are very pleased to welcome Kristen to our team!

In West Baton Rouge parish, Lethal Bronzing Disease was confirmed from a sample taken by an extension agent with the LSU Ag Center. This is a bacterial disease that affects Louisiana host palms; the date palm, Chinese windmill palm and the queen palm plants and is transmitted by a leafhopper. To date, the palm disease has been found in East Baton Rouge, West Baton Rouge, Orleans, Jefferson and St. Bernard parishes.

Citrus Canker was confirmed in Livingston parish on July 24<sup>th</sup> and a survey is being conducted and samples are being taken to determine the extent of any infestation.

The HLB tree removal program is ongoing in Orleans, Jefferson, St. Bernard and Plaquemines parishes. This project is being funded by awarded funds to LDAF from PPA 7721 cooperative agreement.

All professional horticultural licensing exams are now administered on computers. The exam fee remains \$114.00 per exam. The exams are offered at our seven district offices statewide. The transition from paper exam to computer-based exams will provide efficiency to our exam administration process. Applicants will receive their scores immediately following their exam, which will expedite the licensing process.

Tina Peltier, Assistant Director of Horticulture will be attending the CLARB meetings in Missouri next week. This annual meeting provides states an opportunity to discuss matters related to landscape architecture with other state regulatory boards/agencies nationwide.

### **Rule change requests:**

### SOD Classification Form/Exam

**Motion:** Mr. Sims made a motion to adopt the resolution to move forward with the Notice of Intent to amend the rules and regulations regarding the requirement of a SOD classification form and to add regulations regarding cheating during an examination. This motion was seconded by Mr. Hoover and passed unanimously.

### Landscape Architect Exam Revision

**Motion:** Mr. Danos made a motion to move forward with the computer-based exam questions for the Louisiana landscape architect examination. This motion was seconded by Mr. Hopper and passed unanimously.

# **PUBLIC COMMENTS**

Nichole Lefebvre of Louisiana Keepsake Roses is a retail florist and she requested that the Horticulture Commission make a special classification and regulations for "live preserved" roses. These roses are preserved by a glycerin process. These roses are not "fresh" nor are they considered to be "dried" flowers. The roses currently are imported and sold by Ms. Lefebvre. **Motion:** Mr. Danos made a motion to move forward with research into this type of flower process. This motion was seconded by Mr. Mayes and passed unanimously.
