NEW BUSINESS

There was no new business.

Director's Report:

Mr. Rankins gave the following updates:

Citrus canker was confirmed on one grapefruit tree in Plaquemines Parish. None of the trees in the facility where the citrus canker was found can move across state lines, but LDAF will allow the asymptomatic trees to move intrastate within the quarantined area. Since the last meeting HLB has been confirmed on 116 properties with 193 total trees. Of the 266 total positive trees, 234 trees remain to be removed on 142 properties. The biggest obstacle has been property owner consent and education. North Carolina notified us that our state potentially received a shipment of infested cut boxwood products. The products were inspected and found to have no signs of boxwood blight. LDAF has launched a mobile app to allow users to verify licenses and permits or file a complaint. A brief video was shown to demonstrate the app. The app is available for free through Google Play and the App Store.
