The motion was seconded by Mr. Parker and passed unanimously.

Sue Otwell joined our Horticulture team on February 15<sup>th</sup>. Mrs. Otwell will handle all of the permit work in our office, including cut flower, nursery grower and nursery stock dealer permits as well as honeybee registration and other routine duties. We are pleased to have Sue with us.
