Case No.: 13-002

Five violations of L.R.S. 3:3804 (C) for advertising and engaging in regulated professions (landscape horticulturist, landscape irrigation contractor, and landscape architect) without the proper licenses.

Mr. Varnado was present. **Motion:** Mr. Parker made a motion to find Mr. Varnado in violation. This motion was seconded by Mr. Ruckstuhl and passed unanimously. Recommended penalty of \$250.00 per violation for a total fine of \$1,250.00. **Motion:** Mr. Parker made a motion to accept the recommended penalty. This motion was seconded by Mr. Ruckstuhl and passed unanimously.

One violation of L.R.S. 3:3804 (C) for engaging and advertising in a regulated profession (retail florist) without the proper license.

## **NEW BUSINESS**

#### **Director's Report**

Mr. Hardy gave the following updates:

Mr. Hardy continued his participation in the national Systems Approach to Nursery Certification (SANC) initiative by attending a full committee meeting in Maryland in February. SANC is a developing initiative to harmonize nursery grower practices, certifications, and anti-pest activities through voluntary BMPs/recordkeeping at nurseries nationwide.

Mr. Rankins represented Louisiana at the spring CLARB meeting in March in Arizona where he served as session moderator and participant. This is part of his role as a new member of the CLARB Executive Committee.

Changes to the Landscape Architect portion of the Horticulture Law will be working their way through the legislative process this spring. Amendments were necessary to match changes in how CLARB now administers the LARE exam. All Landscape Architects must still pass a state test and obtain a Louisiana license to practice in our state.

Our H&Q Division will be hosting the Southern Plant Board annual meeting April 21-24 in New Orleans. Louisiana hosts this meeting once every 10-12 years. Agenda items include federal and state plant pest issues and activities.

Field inspector training on Landscape Irrigation Contractor inspections was held in February to provide our personnel with more knowledge of irrigation systems and of our existing law, rules and regulations.

For the first time in a number of years, our Horticulture and Quarantine Division is caught up with license and permit renewals (renewal is February 1). This is a testimony to our ability to now maintain a full clerical staff, and is the direct result of the personal dedication of our Division employees.

Mr. Bass took a moment to thank the staff and the Commission members for the job that they do. Mr. Rankins introduced Ms. Nikki Bilbo and Ms. Marsha Dugas as new inspectors at our Baton Rouge office.
