### **PUBLIC COMMENTS**

Dane Morgan addressed the board regarding a resolution that was discussed in the LA Special Session. The resolution is to direct the treasurer to immediately begin developing a procedure necessary to implement development of a process to allocate money deposited into the state treasury from constitutional and statutory dedications that flow through the Bond Security and Redemption Fund for the purpose of paying debt service on obligations secured by the faith and credit of the state beginning in Fiscal Year 2017-2018. Mr. Morgan also presented the commission members with a letter written by Commissioner Strain to The Honorable Ron Henson, Louisiana State Treasurer, informing him that the majority of the statutory dedicated funds within LDAF are exempt from being treated as State General Funds and should not be earmarked for payment of bond debt. The issue will be debated on again in session on April 10, 2017.

## **Director's Report:**

Mr. Rankins gave the following updates:

Citrus Greening was confirmed in Jefferson Parish on February 15<sup>th</sup>, bringing the total number of parishes with HLB+ trees to three. Survey activity is ongoing in coordination with USDA-PPQ.

Emergency Rule became effective on March 3<sup>rd</sup>, that expanded the quarantine for citrus greening to include Jefferson Parish and expanded the citrus canker quarantine to include the entire parish for each parish in which it has been found. This makes for a cleaner, more enforceable quarantine and will make public understanding easier as well. The amendment also adds language requiring citrus nursery stock growers in the Asian Citrus Pyslid, Citrus Greening, or Citrus Canker quarantined areas to attach a tag to each tree with specific wording required.

The H&Q staff will be participating in the 2017 Southern Plant Board meeting in May. This annual regional meeting allows states to address plant pest and green industry issues of concern to the region. The USDA also attends, allowing useful interaction with our federal counterparts.

Christie Lane has joined our Horticulture team on February 1<sup>st</sup>. Christie will handle all of the permit work in our office, including cut flower, nursery grower and nursery stock dealer permits as well as honeybee registration and other routine duties. We are pleased to have Christie with us!

There were no public comments but Mr. Bass took a moment to thank the commission members and inspectors for the good job that they do.
