## **MINUTES**

1. Call to Order and Comments by Chairman. A meeting of the Louisiana Public Defender Board, pursuant to lawful notice, was called to order by its Chairman Michael C. Ginart on Monday, November 15, 2021, at approximately 10:30 a.m.

- 2. Adoption of the Agenda. Mr. Pat Fanning moved to adopt the agenda. Judge Cynthia Woodard seconded the motion which passed unopposed.
- 3. Public Comment. Chairman Ginart indicated that he has received several requests for Public Comment regarding Mr. Paul Marx. He clarified that Mr. Marx has reached out to him and requested that he be allowed to address the Board at the December 16, 2021, meeting. Mr. Ginart asked those present to discuss this issue to reserve their comments for that meeting.
- 4. Executive Session<sup>2</sup>,<sup>3\*</sup>. Professor Donald North moved to go into Executive Session. Mr. Flozell Daniels seconded the motion which passed unopposed. Mr. Daniels moved to leave Executive Session which was seconded by Judge Woodard and passed unopposed.

## 5. District Defender Appointments\*

- a. Regionalization Assessments. This item was not addressed.
- b. District 2. Mr. Lyn Lawrence moved to hire Mr. Steven Gatlin as the District Defender for District 2 (Bienville, Claiborne, Jackson Parishes). Mr. Daniels seconded the motion which passed unopposed. Chairman Ginart congratulated Mr. Gatlin and thanked the other candidates. Mr. Gatlin thanked the Board for the opportunity to serve.
- c. District 6. Mr. Daniels moved to hire Mr. John Hogue as the District Defender for District 6 (E. Carroll, Madison, and Tensas Parishes). Judge Ross Foote seconded the motion which passed unopposed. Chairman Ginart congratulated Mr. Hogue and thanked the other candidates for applying. Mr. Hogue thanked the Board for the opportunity. Applicant Pamela Greer welcomed Mr. Hogue and expressed her eagerness to work with him in the future.
- d-e. District 11 and District 42. Judge Foote moved that the State Public Defender enter into a contract with Mr. Brian McRae to satisfy the duties of the District Defender for District 11 (Sabine Parish) and District 42 (Desoto Parish). Ms. Allyson Prejean seconded the motion which passed unopposed. Chairman Ginart congratulated Mr. McRae and thanked the other candidates for applying.

R.S. 42:17, including character and professional competence of a person; provided, however, such person(s) may require that such discussion be held at an open meeting pursuant to La. R.S. 42:17(A)(1). The Board may interview District Defender candidates in the following districts: District 2 (Bienville, Claiborne, Jackson Parishes) candidates; District 6 (E. Carroll, Madison and Tensas Parishes); District 11 (Sabine Parish); and District 42 (Desoto Parish). The Board may also discuss the District Defender site visit result in District 23 (Ascension, Assumption and St. James Parishes).

R.S. 42:17, including strategy sessions with respect to litigation and prospective litigation. In accordance with La. R.S. 42:19(A)(b)(iii), the Board may discuss the following: Jami Pellerin vs State of Louisiana, through Indigent Defender Board, 15<sup>th</sup> Judicial District Indigent Defender's Office and G. Paul Marx, Chief District Defender for the 15<sup>th</sup> Judicial District Indigent Defender's Office, 15<sup>th</sup> Judicial District Court, Docket: c-202116471, Lafayette Parish; Joseph Allen et al v. John Bel Edwards, et al, Docket: C655079, Section 27, 19<sup>th</sup> JDC, Parish of East Baton Rouge.

- f. District 23 Appointment of Interim. Mr. Starns reported that the District 23 (Ascension, Assumption and St. James Parishes) District Defender Alan Robert has submitted his resignation effective November 30, 2021. Mr. Starns indicated he is recommending District 17 (Lafourche Parish) District Defender Andrea Stentz as Interim pending the appointment of the permanent District Defender in that district. Mr. Daniels moved to accept Mr. Starns' recommendation to hire Ms. Andrea Stentz as the interim District Defender for District 23 (Ascension, Assumption and St. James Parishes). Mr. Lawrence seconded the motion which passed unopposed.
- 6. State Public Defender Authority to Hire Personnel and Set Salaries. Judge Foote moved that this item be deferred to the next meeting (Dec. 16, 2021) after the Budget Committee has had the opportunity to review and/or address salary ranges and that personnel be given performance evaluations. Judge Woodard seconded the motion which passed unopposed.

Judge Foote asked if the Zoom meeting information and materials will be sent out prior to the "O" Level Funding meeting scheduled for November 17, 2021 in Marksville. Mr. Starns indicated he would provide that information.

Returning to 5(f), General Counsel Barbara Baier asked for clarification on the salary for the interim district defender (Andrea Stentz) in District 23 (Ascension, Assumption and St. James Parishes). Mr. Starns reported her salary is to be \$3,000 per month.

Returning to 5(b)(c)(d)(e), Mr. Fanning asked for clarification on the salaries for the other newly appointed district defenders. Mr. Starns reported the salaries should be \$84,000 for all but it is for the Board to decide. Judge Foote inquired if their salaries could be set at \$84,000 and revisited at a later date. Mr. Starns clarified that the earlier discussion was for District 2 (Bienville, Claiborne, Jackson Parishes) District Defender salary to be \$84,000 and for District 6 (E. Carroll, Madison, and Tensas Parishes) to be \$100,000. Mr. Fanning then moved that the District Defender salary in District 6 (E. Carroll, Madison, and Tensas Parishes) be set at \$100,000. Ms. Prejean seconded the motion which passed unopposed. Mr. Lawrence moved that the District Defender salary for District 2 (Bienville, Claiborne, Jackson Parishes) be set at \$84,000. Judge Woodard seconded the motion which passed unopposed. Mr. Starns indicated he also needs a salary set for Mr. McRae at the same rate he is being paid now in three all districts. Mr. Lawrence moved to pay Brian McRae the same rate in all 3 districts – Red River, DeSoto and Sabine at the same rate he is being paid now. Judge Foote seconded the motion which passed unopposed.

**8. Adjournment**. Mr. Fanning moved to adjourn which was seconded by Mr. Lawrence and passed unopposed.
