The meeting of the Louisiana State Racing Commission was called to order by the Chairman on Monday, August 19, 2013 at 9:05 AM in the Queen Anne Ballroom of the Monteleone Hotel, 214 Royal Street, New Orleans, Louisiana. Roll call was taken; a quorum was present.

1. PROGRESS REPORT, by Mr. Chris Warren. Mr. Warren informs that Delta Downs 46 day, 2013 Quarter Horse Meet ended on July 13, 2013. He informs the live handle was flat, the bet-in handle was up 6% and the simulcast handle was down 3%. Overall the handle was up 4% for all three segments of wagering at the track. He informs of record purses which were over \$8 million for the meet. He informs the 88-day, 2013-14 Thoroughbred Meet will begin on October 11, 2013. He informs \$250,000 per race day will be distributed in purse money. He states their Jackpot Race will be held on Saturday, November 23, 2013 and Premiere Night on Saturday, February 1, 2014. He informs Delta Downs is currently working on the backside stalls, replacing walkers and other upgrades as well as purchasing a new water truck.

Mr. Steve Kuypers, Vice President/General Manager of Delta Downs, thanks the Commission for their support given to Delta Downs and Boyd Gaming. He introduces Brett Cox, the new General Manager of Evangeline Downs to the Commission. Mr. Cox informs that he has been on the job for four months and is looking forward to working with racing and building on an already successful racetrack and casino property at Evangeline Downs.

Mr. Warren informs Delta Downs will be implementing an in-house rule regarding LAC 35:V. 6353 "Entry after Excused" in the first condition book for the 2013-14 Thoroughbred Meet. This change mandates that a horse scratched and placed on the 3-day veterinarian's list will be automatically scratched from any and all races it may be entered at the time of the initial scratch.

## B. OLD EVANGELINE DOWNS d/b/a EVANGELINE DOWNS RACETRACK & CASINO

1. PROGRESS REPORT, by Mr. Steve Darbonne. Mr. Darbonne informs Evangeline Downs 84-day 2013 Thoroughbred Meet will end on September 7, 2013. He informs, so far, the on-track handle is down 12%, the simulcast handle is down 1.5% and the combined total handle is down about 2% from last year. He informs the 46-day Quarter Horse meet will begin on October 2, 2013. He states Evangeline Downs will also implement the same in-house Rule, LAC 35:V. 6353 "Entry after Excused" in their 2013 Quarter Horse Meet first condition book.

# C. CHURCHILL DOWNS LOUISIANA HORSERACING COMPANY, LLC d/b/a FAIR GROUNDS RACE COURSE & SLOTS

1. PROGRESS REPORT, by Mr. Eric Halstrom. Mr. Halstrom informs the start of Fair Grounds 2013 quarter horse meet was delayed due to the threat of severe weather. Races were cancelled Friday, August 16, 2013 and Saturday, August 17, 2013. He informs racing will start on Wednesday, August 21, 2013. He informs trials for the quarter horse breeder's futurity have been rescheduled for Friday, August 23, 2013. He informs that Saturday, August 24, 2013, will include 5 stakes races as well as exotic racing. Mr. Halstrom informs the turf course conditions are improving under the instructions of Dr. Mick Peterson. He informs a new type of Bermuda grass along with different herbicides and fertilizer are being used for the turf course in preparation of the 2013-14 Thoroughbred Meet in November. He informs the Louisiana Derby, with an infield festival, will be held on Saturday, March 29, 2014. He informs that last year's infield festival attracted 3,500 people and this year's goal is to have between 5,000-10,000 patrons in attendance. The Fair Grounds sent out stall applications for the upcoming thoroughbred meet with a closing date of October 1, 2013.

Mr. Meaux asks Mr. Halstrom to expound on how Fair Grounds will make up the two cancelled 2013 quarter horse race days. Mr. Halstrom informs Fair Grounds will add extra races to the current race days. Mr. Halstrom states Fair Grounds is in compliance with the minimum 10 race days that are mandated. Mr. Meaux states the Commission will ask all tracks for a 3-week gap between the trials and the finals for priority testing, which is now not in compliance. Mr. Meaux states the Commission was not asked for input regarding the cancellations. Mr. Halstrom apologizes and informs due to past severe weather and extensive damage over recent years, Fair Grounds made a quick decision to cancel the two race days. Mr. Meaux informs that the Fair Grounds has cancelled two days of quarter horse racing two years in a row. Mr. Halstrom states he is not prepared to add more race days today. He informs Fair Grounds is willing to discuss/negotiate this matter further, but prefers to do so not during this public Commission meeting.

Mr. Laverne Perry, Director of LQHBA and Mr. Stanley Seelig, President of the Louisiana HBPA voice their opinions on behalf of their respective organizations and ask Fair Grounds to add two race days to the end of their 2013 quarter horse race meet. Mr. Halstrom states he will work with Mr. Perry, Mr. Seelig and their associations in order to rectify the situation.

Mr. Babb states for the record, he is in support of the horsemen.

Mr. Wright and Mr. Meaux ask Mr. Halstrom to start discussions/negotiating with the horsemen and suggest all parties come to a resolution by the end of this Commission meeting. Mr. Meaux informs the Bonnet Carre Meeting Room is now available, so all parties can meet.

Dr. Larry Finley of the LQHBA, informs he has been practicing veterinary medicine for 35 years and states the significance of the 21-22 days of recuperation needed for the welfare of 2-year olds before racing in a high stakes futurity.

## D. HARRAH'S BOSSIER CITY INVESTMENT COMPANY, LLC d/b/a HARRAH'S LOUISIANA DOWNS

1. PROGRESS REPORT, by Mr. Trent McIntosh. Mr. McIntosh informs Louisiana Downs is three-quarters through the 84-day 2013 Thoroughbred Meet which began on May 3, 2013, and after 63 days of racing; the handle is up 5%. He informs the Pick Five Wager has become very popular this year due to a large jackpot and has drawn immense wagering interest from around the country. He states the Jackpot grew to \$890,000 in early August when it was finally won. He states the Pick Five Wager sparked new life in wagering at Louisiana Downs and will be used more aggressively in the future. Mr. McIntosh informs Super Derby is in three weeks and club seating for 600 people as well as the suites are already booked. He states there are a few box seats available and there are seats remaining in the Sky Room for buffet and fine dining.

Dr. Grimstad comments that the Pick Five has had some success, but there was some negative publicity on this bet in Louisiana when someone mistakenly thought they had won \$500,000. He says it turned out that the horse had been scratched earlier in the day which led to negative national press. Dr. Grimstad asks Mr. McIntosh what has been done to prevent this from happening again. Mr. McIntosh states there was some bad press and that this was a learning process. He informs that probables cannot predict the accuracy of the favorite at post time and they no longer show probabilities on this wager. He states it often happens in the Pick Four, but it was exposed since the Jackpot was so large. Dr. Grimstad says he recognizes the bet has been a revenue producer for the tracks. He expresses his reasons why it is a questionable bet and why it is not a favorable deal for the patron.

Mr. McIntosh informs Louisiana Downs will also be implementing an in-house rule regarding LAC 35:V.6353 "Entry After Excused" in their first condition book. A horse scratched and placed on the 3-day veterinarian's list will be automatically scratched from any and all races it may be entered at the time of the initial scratch.

Mr. Babb informs the amendment of LAC 35: I. 1797 allows the stewards to redistribute the purse for violations of ARCI Category IV and V at severity level 3 and third violations of ARCI Category IV and V at any severity level within a 12-month period.

- E. RACETRACK/HBPA LIAISON COMMITTEE, by Committee Chairman Kevin Delahoussaye

Mr. Delahoussaye informs he spoke with Mr. Trent McIntosh regarding some backside renovations at Louisiana Downs and the renovations should be completed by the first quarter of 2014.

#### III. OTHER

## A. Groom Elite Horseman's Education Program:

1. Presentation by Dr. C. Reid McLellan, Executive Director, regarding programs to increase the understanding of the horse and enhance professional skills. Dr. McLellan informs the Commission of his educational background and work experience in the equine industry. He provides information regarding the Groom Elite Program which was founded by Sue O' Hara and was first taught at Lonestar Park in 2001. He informs the Program was implemented in Louisiana for a short while in 2003, but hasn't been taught since. He informs Groom Elite has since moved into several other states as a vocational program. Dr. McLellan informs he recently met with the Office of Juvenile Justice for the state of Louisiana to develop a Groom Elite Program in Baker, Louisiana for at-risk juveniles working with retired thoroughbreds. He provides more information to the Commission and asks for their support in developing this

## B. Louisiana Horse Rescue Program (LHRA):

program at racetracks in Louisiana.

1. *Presentation by* Michelle Rodriquez, Sunny Francois and Theresa Arroyo regarding LHRA.

Ms. Sunny Francois, Executive Director of LHRA, presents and reviews slides of the LHRA as well as distributes hand-outs to the Commission for further distribution to the racetracks and horsemen. She informs Louisiana currently has zero dedicated funding for thoroughbred retirement and welfare despite having the infrastructure to do so. Ms. Michelle Rodriguez explains some of the difficulties they are encountering when rescuing horses. She informs the National Thoroughbred Racing Association (NTRA) requires, pursuant to their 2013 Code of Standards, that racetrack members shall participate in sharing the cost of funding among racing participants through mutually agreed upon methods. She informs Florida, Kentucky, Maryland, Illinois, New York and Pennsylvania have already responded with funded programs. She informs of two ways in which Louisiana can implement funding. One option is a pay-per-start program and the other is a purse percentage contribution. Mr. Guilbeau informs that it is important to receive input from each track and the horsemen since they are the ones being asked to support the program.

Ms. Francois explains how their non-profit organization and salary structures are organized and their current funding resources as well as how the program will benefit

the industry. Ms. Francois further reiterates how her organization takes care of retired horses and their general welfare. She states their non-profit organization is working towards getting NTRA accredited. Ms. Rodriguez informs she has met with several track representatives around the state and has received positive feedback regarding their program.

Mr. Guilbeau, Mr. Meaux, Ms. Francois and Ms. Rodriquez discuss different methods of funding and other thoroughbred rescue non-profit organizations in the state requiring funding as well.

Mr. Stanley Seelig states the HBPA supports horse rescue and would like to help in any way they can. He informs the state statutes, as currently written, will not allow for a portion of the purse structure to be given to an outside party. Mr. Seelig recommends an opt-in approach because it would be a personal choice by an individual. Mr. Seelig states his legal concerns regarding the flow of money and the responsibilities by all parties involved. Mr. Guilbeau agrees with Mr. Seelig regarding the legal issues involved. Dr. Grimstad, Ms. Rodriquez and Mr. Meaux give their opinions on the potential legal matters involved, as well as, continue with more discussion about the opt-in and opt-out scenarios. Mr. Wright asks the Legal Committee to study the matter further. Mr. Halstrom informs Minnesota had an opt-out per start for their rescue program. Mr. Guilbeau, Ms. Loney and Ms. Rodriquez discuss legal issues, audits and legislature concerns.

Mr. Hollier motions to approve Rule LAC 35: XIII.11003 for Formal Adoption; Mr. Babb seconds; motion carries.
