CALL TO ORDER

Proposed Rule Changes

- i. LAC 7:XXV.101 – Definition of General Pest Control: Removal of “Residential rodent control will be limited to the use of anticoagulant rodenticide and traps” from rule wording.

Motion: Mr. Jeff Hargrave made a motion to accept the proposed rule. The motion was seconded by Mr. Kevin Poole and passed unanimously.

- ii. LAC 7:XXXV.109(G-H) – Application for Examination: Contents of Application – Exams, allowing applicants approved by the commission to take their exams upon request at a department approved location and removing written from the rule wording.

Motion: Mr. Jeff Hargrave made a motion to accept the proposed rule change. The motion was seconded by Mr. Jeff Porter and passed unanimously.

- iii. LAC 7:XXV.141(E)(4) – Minimum Specifications for termite control work; Pre-Construction Treatment – pretreatment notifications, allowing for the online submission of pre-treatment notifications.

Motion: Mr. Jeff Porter made a motion to accept the proposed rule change. The motion was seconded by Mr. Kevin Poole and passed unanimously.

- iv. LAC 7:XXV.107(F)(3) - Removal of written from rule wording.

Motion: Mr. Jeff Hargrave made a motion to accept the proposed rule change. The motion was seconded by Mr. Bryan Billiot and passed unanimously.
