LA WORKERS' COMPENSATION SECOND INJURY BOARD

Meeting of November 7, 2019

The regular meeting of the Second Injury Board convened at 2:01 p.m.

Mr. Hawkland called the meeting to order and began with *Item 1* on the agenda, being the reading of the minutes from the previous meeting.
