II. APPROVAL OF MINUTES

A motion was made by Mr. Ben Langlinais, seconded by Mr. William Patout, that the minutes of the May 3, 2012 Iberia Parish Levee, Hurricane, and Conservation District be approved.

II. ACTIONS TO BE DISCUSSED

A. Mr. Dale Bergeron - presentation on water bag levees.

Chairman Gonsoulin announced that Mr. Bergeron was unable to attend the meeting.

B. Approval of Invoice #212232 to Berard, Habetz, and Associates.

A motion was made by Mr. Alfred "Todd" Landry, seconded by Mr. Frank Minvielle approving payment of Invoice #212232 in the amount of \$915.00 to Berard, Habetz, and Associates.

And the motion was therefore passed on this 7th day of June, 2012.

C. Review outcome of Committee meeting and presentations given to the Village of Loreauville and other Organizational Clubs. Discuss Resolutions of support from Parish Organizations.

Mr. Landry stated that he conducted the meeting for the Village of Loreauville. Others in attendance were Mr. Oneil Malbrough, Mr. James Landry, Mr. James Stein and Mr. Marc Berard. He noted that he thought the presentation was received well and that the Village will vote on a Resolution of support at its next official meeting.

Chairman Gonsoulin requested that Mr. Ronald Hebert visit the City of Jeanerette and seek a Resolution supporting the District's endeavors for a proposed tax, upon the District's approval of an example Resolution of Support¹.
