#### APPROVAL OF NOVEMBER 30, 2022, APRIL 19, 2023, AND JULY 20, 2023 MINUTES

Due to the absence of a quorum, approval of the minutes of the November 30, 2022, April 19, 2023, and July 20, 2023, meetings was deferred to the next meeting of the Council.

### STRATEGIC PRIORITIES FOR SMTEC-LA

Chair Lofaso reminded the members of the purpose of the Council and its strategic properties.

#### • Lunch and Learn Zoom Session:

The Lunch and Learn was held in September 2023. Dr. Melissa Madden presented on the topic, "Selecting and Developing Simulation Scenarios and Cases" and 37 participants were in attendance. Chair Lofaso considered the next Lunch and Learn topic and guest speakers, reviewing topics obtained from the survey administered. Chair Lofaso suggested the Council create a website to host the Lunch and Learn series recordings. An alternative suggestion was to post the recordings on YouTube.

#### • Council Newsletter via Email:

The newsletter will be reconsidered in the coming year as the Council is currently focused on creating a website, collecting emails, and preparing for the Simulation Expo.

# • 2024 Sim Expo

Chair Lofaso provided the Council with an update regarding the Simulation Expo, scheduled for April 19, 2024, at LSU Health Sciences Center - New Orleans' Human Development Center. The budget for the event is \$43,200, which will be for 300 attendees. The Council released a call for abstracts on October 30, 2023, with a response deadline of January 15, 2024. Council members were

tasked to send out the call for abstracts to their designated bodies. Chair Lofaso also reviewed the Expo website:

#### • Funding

The Health Works Commission approved \$63,000 in funding for SMTEC-LA. With this amount and the funding for the Sim Expo committed, the Council has a budget of \$19,800 remaining. Chair Lofaso opened the floor for ideas to utilize the balance. AHEC was suggested for use of their summer camp. Ms. Mellynn Baker expressed concern regarding having an open rather than selective proposal process. Ms. Baker also reminded the Council that the funds must be utilized by June 30, 2024, and suggested the project be selected by the executive committee.

Chair Lofaso indicated that the next Council meeting would be hosted in Baton Rouge during summer 2024.
