<u>APPROVAL OF NOVEMBER 30, 2022, APRIL 19, 2023, JULY 20, 2023, AND NOVEMBER 9, 2023, MINUTES</u>

Mr. Lofaso called for a motion to approve the November 30, 2022, April 19, 2023, July 20, 2023, and November 9, 2023, meeting minutes. On motion of Mr. Maranto, seconded by Ms. Warner, the minutes were approved.

#### STRATEGIC PRIORITIES FOR SMTEC

Dr. Lofaso shared that this council's mission is to enhance the effective use of simulation training for students, faculty, residents, fellows, and practitioners throughout the state. He shared that members have agreed upon doing this through educational opportunities and opportunities to convene like webinars and the Sim Expo.

#### **Lunch and Learn Conference**

Dr. Lofaso shared information regarding the Lunch and Learn conference that occurred on February 29<sup>th</sup>, 2024. He stated that the topic of discussion was Developing Interprofessional Simulation-Based Education and that presenters included Sharonda Johnson, Simulation Coordinator, Senior Nursing Instructor, UL at Lafayette Certified Online Instructor/Course Designer, and the University of Louisiana at Lafayette. There was discussion of hosting the next Lunch and Learn in September.

# Sim Expo

Dr. Lofaso then shared information regarding the 2024 Sim Expo, which occurred in April at LSU Health Sciences Center - New Orleans. He indicated that the funding requested from the Board of Regents was \$43,200, the total cost was \$22,510.06, and the remaining balance was \$20,689.94. He noted that national speakers Michael Seropian and Dawn Taylor Peterson

attended the Sim Expo. There were 14 presentations from 11 different organizations; 235 individuals registered for the conference and 194 individuals attended the conference. The majority of the attendees were nurses. He noted that attendees represented 26 of Louisiana's 64 parishes, 46 educational facilities, and 10 exhibitors. Evaluations showed that 96% of participants stated that the conference format met their expectations.

Additional feedback from the Expo showed that:

- The conference provided a platform for simulation professionals to share best practices, network, and build relationships.
  - o Definitely Yes: 56.58%, Yes: 38.16%
- The conference enhanced the effective use of simulation training in the health professions by improving teaching skills, communication, problem-solving, and research.
  - o Definitely Yes: 60.00%, Yes: 34.67%
- The content was up-to-date and accurate.
  - o Definitely Yes: 60.53%, Yes: 38.16%
- The speakers were prepared.
  - o Definitely Yes: 67.11%, Yes: 32.89%
- The content was at an appropriate level for the audience.
  - o Definitely Yes: 64.47%, Yes: 32.89%
- How satisfied were you with the registration process?
  - o Very Satisfied 73.69%, Satisfied 23.69%
- How satisfied were you with the venue?
  - o Very Satisfied 73.69%, Satisfied 25.00%
- How satisfied were you with the scheduling?
  - o Very Satisfied 69.74%, Satisfied 23.68%
- How satisfied were you with the instruction?
  - o Very Satisfied 68.42%, Satisfied 23.68%

Many individuals left positive comments about the conference. Some other feedback included that individuals had trouble parking, limited time was provided to network with others, and dress code instructions were not clear.

## **Camp Fast Forward**

Ms. Brooke Voorhies shared updates regarding Camp Fast Forward, an experience designed to get middle schoolers interested in healthcare careers through medical simulation. She noted that the camps were held in Iberia Parish, Lafayette, and Calcasieu Parish and collectively engaged 78 students. The students have the opportunity to receive CPR certification as well as interact with healthcare professionals. She noted that students enjoyed the camp.

#### **ULL - CHSE Review Course**

Dr. Sharonda Johnson updated the Council on the Certified Healthcare Simulation Educator (CHSE) review course. She shared that the review was held via Zoom on June 17<sup>th</sup> from 8:00 a.m. to 5:00 p.m., engaging 16 participants. Each participant received a certificate of completion and was given access to a CHSE practice exam. This was a review session for those interested in being certified through CHSE.

### **OTHER BUSINESS**

There was discussion of the next meeting, to be held place in November at the Board of Regents on the same day as the Nursing Supply and Demand Council.
