- V. Old Business/Announcements: Bren Haase, CPRA- Acting Chairman
- VI. ARBRE Task Force Recommendations to the CPRA Board Brian Lezina, CPRA (Video:)
 - Mr. Lezina presented the Task Force with the final edits that incorporated their feedback/changes in the Atchafalaya River Basin Restoration and Enhancement Task Force Plan.
 - o Introduction and Purpose section
 - Minor additions to the history and geography.
 - Recognition that the Basin has a mixture of ownership.
 - Better classify the challenges faced by the Basin.



- Enhance outreach that highlights the importance of the Atchafalaya Basin, locally, regionally, and nationally
 - Minor changes to better recognize the range of important habitat types and the importance of navigation.
 - Mr. Leroy Blanchard expressed concerns with the wording of "degradation" on page 11 of the draft plan.
 - Mr. Lezina acknowledged Mr. Blanchard's concern and stated that a period would be placed after economy and discontinuing the sentence with "degradation continues".
- Urge and request Congress fully fund construction of finalized USACE studies relevant to the management of the Atchafalaya Basin as well as fund authorized studies
 - Minor changes to better recognize protection and restoration of multiple habitat types.
 - Projects should be deemed beneficial not just simply because of incorporation in previous plans.
- Urge the USACE to approach management of the Atchafalaya Basin holistically, designating ecological restoration as a primary component along with flood control and navigation.
 - Minor edits to mention carbon sequestration.
- Request the CPRA Board evaluate inclusion of the remainder of the Atchafalaya Basin within the Louisiana Coastal Zone.
 - Revised to request that an evaluation should be performed to better understand the impacts.
 - The Task Force should be consulted by CPRAB to better understand benefits inclusion.
 - Specific language concerning potential outcomes was removed.
- Management actions should where possible restore north/south sheet flow within the Basin
 - Added language to reflect the "spoil bank inventory" and any resulting implementation should be done in consultation with public and private landowners.



- Management actions should where possible, restore and conserve deep water habitats within the Basin
 - Minor edits to emphasize protection of "critical" habitats
 - Mr. Sparks expressed concerns regarding the language of "deep water habitat". Is it possible to more specifically define what is meant by deep water habitat?
 - Mention that spoil should be deposited in upland or adjacent elevated areas.
- Examine ways to better manage sediment within the ARB
 - Edits to clarify that the USACE should fast track a study to examine dredging at the river outlets.
- Examine the current hydrology of the ARB, including management of the ORCC and the ARB channel outlets
 - No significant edits
- Update the State's Atchafalaya Basin Mater Plan to include current conditions and challenges as informed by the ARBRE Task Force.
 - No significant edits
- CPRA Board and CPRA to enhance public engagement concerning the management of the Atchafalaya Basin
 - Edit to suggest that any outreach concerning waterways should reference publically available waterways.
- Recommend the ARBRE Task Force be used to discuss and inform potential management actions within the Atchafalaya Basin
 - No significant edits
- Explore opportunities for significant recurring funding for the Atchafalaya Basin Program
 - No changes
- Work Plan and Meeting Schedule
