Funding

Chairman Hebert spoke about the work of the Funding for Deep Water Ports Working Group and how the commission hopes to have a funding mechanism to present to the Legislature for the 2025 Regular Session.

Gap Sensors

Toby Wattigney of the NOBRA pilots and Mac Wade of Morgan City spoke about working with the NOAA to get Air Gap Systems and potential ways the state may help with the costs.
