Finances, Personnel, and Operations

We received payment of \$150,610 from DRA on site work at the seafood hub. Our current fund balance is \$148,893.88 (as of 8/16/2025.) We had a net profit in the operating budget of \$491,971.88 but we spent \$663,503.75 on engineering and construction. That is a difference of \$171,531.87 from construction cost that caused a cash shortfall. That includes purchase of the pay station. I drafted an amended operating budget for the remainder of the year, but it is short \$116,637.28. It reduces our original budget expenses by \$167,311.96.

In September 2021, we took out a \$1m bond to cover our match for the Bagwell project. There was also a \$100,000 drawdown of a \$4.5m grant anticipation note that we did not use because of delays with the grants. We exhausted those bond funds as follows:

To meet upcoming construction costs and replenish the operating cash used for construction, I met with a Gulf Coast Bank loan officer to discuss our borrowing options. Local government with sales or property tax revenue routinely borrow against those revenues to construct projects of all kinds like roads, bridges, schools, sewer plants, and practically all other infrastructure projects. The benefit of building projects now far outweighs waiting 10, 20, or more years to collect the funds before building the project. Government borrowing is not like borrowing for a home. The bank is limited to collection only from those designated revenue streams. It is a sum certain in the future reduced to the present. For local government, it is the customary way of doing business.

We can apply for grant anticipation notes for each of the grants as they become approved/final. We can also apply for a long-term bond and a bond anticipation note (while bond approval is pending.) Bond approval is done by the state bond commission. I am attaching the memo I sent to the bank for the USDA RISE Grant (without attachments.) The bank officer is prepared to go to his loan committee with the RISE loan. I asked him to wait pending board approval. I will send him additional memos on each grant.

The origination fee on each loan is .5% of the line of credit requested. The interest rates are approximately 5.9% on tax free loans and bonds, and 7% otherwise. The grants, projects, and related notes and bonds are listed below:

The above loans are lines of credit that do not incur interest until the funds are needed. Because of the origination fee, we will not need the entire amount listed above except for the USDA RISE GRANT. The USDA payment policies are different than the other grants. When I get confirmation from the agency, we can adjust the amount needed accordingly.

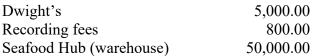

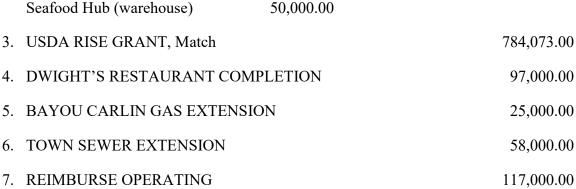

For the long-term bond amount, I did not include interest and expenses. I will discuss the projects with the bond attorney. By my figures, we have a total bonding capacity of \$3.1m. So we only need one third of that amount. The bond anticipation note will only need to be enough to cover the time period to get the bond approved by the state bond commission.

I am asking for authority to apply for these loans and bond, but not final approval until a complete draft and final figures are complete.

Industrial Expansion

We have full authority to proceed with the related projects. The engineers need authority to proceed with bidding for the marine work, which is vessel removal, dredging at South Dock, dredging at the Bagwell Slip, bulkheading, and shore protection.

The Bagwell construction phase will follow soon after.

Seafood Hub

Planning and design is on hold until financing is secured.

On the warehouse, we prepared a subrecipient agreement with Vermilion Parish. The funding agency has not given final spending approval but we can proceed with design that will be handled by our engineers.

Farmers Market

The August market was well attended with 1,048. The concession stand made a profit of \$1,379.27.

Seafood

I will distribute the job duties for the dock master position that we hope to begin in January 2026. I will have the seafood sales report on Monday.

Louisiana Direct Seafood Shop.

We received inventory for oysters, snapper, grouper, and crawfish. Shrimp, crabmeat, softshell crawfish are on hold until we get more funds.

Marina

I received several calls for dockage, two sailboats and a houseboat. I quoted \$250 under 40', \$300 under 50', \$350 over 50'.

Bayou Carlin Cove

Enforcement

For the ordinances previously introduced, we have to schedule a hearing at the next meeting. The ordinances can be adopted at that time.

Pay Station

We lost internet service on July 14 but I didn't notice it until July 16. I checked the connections but had to call Delcambre Communications to assess it.

Dwight's Restaurant

We held an inspection of the building and prepared a punch list for the contractor. There is additional site work to be done before substantial completion. We hope he can reach substantial completion before end of the month.

The estimate below to install 2" PE Gas Line and 2" PE Riser and tie into Town of Delcambre 2" PE Gas Main.
