2. Review/Acceptance of the last Board meeting's minutes (October 24, 2019)
3. **Vote** on **Elite CEU** – Residential Fire Alarm Technician as an Initial certification course for Fire Alarm. Board member Jeffrey Okun was to review course and present his opinion to the board if course should be Fire Alarm or Household Fire instead prior to voting.
4. **Vote** on the three (3) **FED Learning Center (a BHC Company)** courses presented on October 24, 2019 meeting. The courses being considered as Initial certification courses are as follows: Kitchen Suppression Systems course for Kitchen Suppression, Portable Fire Extinguishers course for Fire Extinguishers, and Fire Alarm Systems course for Fire Alarm. 5. **Vote** on **Locksmith Trainers, LLC** dba Foley Belsaw Locksmithing – Professional Locksmithing course as an Initial course for Locksmith. Board member Jeffrey Okun, Donald Wilkins Jr., and Paul (?) are to review course and present their opinion of this course to the Board prior to voting.
6. **Accreditation & Certification Institute** – Todd Thomas will present the course to be considered as an Initial certification: Gate Automation Technician Certification course for Gate System qualifier.
7. **Vote** on **American Fence Association** - Gate Operator Installer School course.
8. **Review the LLSSA Challenge Exam** for LLSSA Level 1 – Property Protection Technician. This exam, in lieu of taking the three-day course for Level-1 training. The exam is 150 questions. Successful exam completion would be equivalent to LLSSA Level-1 Property Protection Technician Course.
9. **Complete Electrical Academy** (previously named The Alarm Academy)-Steve Evers will present Security Technician Initial certification course for name change.
10. **Complete Electrical Academy** – Steve Evers will present the Electronic Security Technician Continuing Education course to be considered as a CEU course for Security.
11. **Vertical Transportation Education Center, LLC** - Rene' Marques will present Certified Elevator Technician Continuing Education Seminar 2019 to be considered as a CEU course for Conveyance Device Mechanics

13. **Hoist & Crane Service Group** - Kathy Camp will request the current law be revised for 4 years to allow the time required for elevator mechanics working in Louisiana to obtain the CET or equivalent training required by the new Louisiana elevator law.
14. **Hoist & Crane Service Group** – Kathy Camp will request grandfathering elevator mechanics (currently working in Louisiana) be allowed in Louisiana to keep elevator mechanics currently working in Louisiana, from losing their job due to the new elevator law.
15. **Vote on Hoist & Crane Service Group** – HCCET as an Initial certification course for Conveyance Device Mechanics. Subcommittee met December 19, 2019. Board members Kirk Caron and Francois Camunzuli will report to Board.
16. Discussion of requiring Conveyance Device qualifiers to submit the Administrative Rules and Plan Review/Life Safety Code courses upon taking for the first time and every year. Decide on start date. This was to be discussed by Conveyance Device subcommittee. Suggestion of January 2020
