PUBLIC HEARING NOTICE

The proposed 2021 budget for the Red River Waterway Commission is available for public inspection. The Red River Waterway Commission will hold a public hearing on the proposed budget to be held on December 16, 2020, 8:30 a.m., at the *Red River Waterway Commission's Grand Ecore RV Park Activity Center* located at 1071 Tauzin Island Road in Natchitoches, Louisiana. This meeting will be held in accordance with Louisiana R.S. 42:17.1 as a result of the COVID-19 Public Health Emergency, which provides for a public body to conduct, and its members to attend and participate, in a meeting via electronic means, when the Governor has declared a state of disaster or emergency in which a public meeting could be detrimental to the health, safety, or welfare of the public. Considering an unknown and indefinite period in which the state of emergency may be in effect, and in accordance with Louisiana R.S. 34:2308, which states that the Commission shall constitute an instrumentality of the State of Louisiana exercising public and essential government functions, this notice shall certify that the items on the agenda are deemed to be matters that, if delayed, will cause curtailment of vital public services and/or matters that are critical to the continuation of the business of the Commission and that are not able to be postponed.

The public hearing shall be held, and Commissioners and the public may participate, in either of the following methods:

- In a physical setting at the Grand Ecore RV Park Activity Center located at 1071 Tauzin Island Road in Natchitoches, Louisiana. Occupancy for the Activity Center is limited to 40 people. Temperature checks will be administered and proper face coverings will be required before entrance into the Activity Center. Social distancing will be employed in the seating arrangement and all attendees will be asked to observe social distancing requirements at all times and to wear proper face coverings.
